The named parties have been spreading misinformation, derogatory, stating multiple bigoted racist comments & continuous attacks upon the Kenworthy children, Shayling Kenworthy, and Lee Kenworthy. Multiple hate crimes including threats of physical violence/harm, unlawful detainment while posting our physical address stating "I hate cops, I am a fraud, out for money not justice against these 'good men' " friends of some of the parties, Officer Martin & Officer Reina. This geared/aimed hateful, slanderous & orchestrated attack is causing imminent danger for the Kenworthy family and irreparable harm for personal & professional image, further impeding truth, justice, and ongoing future endeavors of the Kenworthy/Sang family.

Heather Christensen along with Cally Esposito have been supplying false erroneous misleading, damaging & harmful information to discredit and harm me my family and have by so created a public safety risk for my family and Samantha Brown with their illegal liable actions against us in targeted aimed manner with a criminal intent to discredit unlawfully detain hide alter our lives and freedoms and truth along with others they have for months knowingly supplying false information to a group/gang of cyber stalkers who are continuously slandering my family making statements like I killed Shayling Kenworthy, anyone participating in this group both with personal relationships with me Samantha Brown my family and the officers involved with killing Shayling Kenworthy are absolutely breaking the law attacking disrespecting & purposely discrediting me for the actual killer's benefit of escaping any accountability... Putting my address up, reporting about my rent, movements, when people are moving out before me or our landlord was aware.

These actions are not only intimidating, but it shows supplying of inside information including when the division workers were at my house, that both, Cally Esposito and Heather Christensen, supplied with false narratives stating, I'm crazy, I need medication when they both know I do not, lying about Monet stolen and allowing the gang my address and making statements to call the police if I am seen in public that I am a danger & need to be hospitalized before I hurt someone. More false, endangering statements like I hate police officers, I am a fraud, drug addict, child molester, pedophile, murderer and it keeps going again providing my physical address putting me in direct physical harm.

Then state advocate licensed Clara Balcacer – Colon who states that she is personal friends of officers involved in Shayling's death/murder also working with Cally Esposito & Heather Christensen to obtain false restraining orders after attacking my family, my home, our credibility for both Officer Reina & Officer Haggerty and Robert Martin's benefit stating that I am a fraud, delusional, need hospitalization, dangerous immediately with 6 months attacking my family with her reputation now trying their out false charges for exposing them causing immediate danger and absolute irreparable harm to my family life and future...

All police stations contacted about this cyber stalking putting up my address trying to orchestrate situations and false charges/false welfare checks and situations that can put my life in eminent danger given the wrong discriminating officer like the Bound Brook police sergeant called to inform Bound Brook Police of possible impersonation of officer in their town on Facebook. The Bound Brook sergeant fully illustrated when he chose to work with the gang's agenda in stalking,



harassment, and attempting to bind me in a false welfare check after threatening me rather than finding out who's online, impersonating an officer from his department making threats hate crimes against my self and my family.

For the FBI to also have been contacted and continue allowing a cyber attack with hate crimes, false charges, false welfare checks and threats of violence from the gang stalking of a victim of police brutality who lost his wife creating imminent danger and irreparable harm to my family and Shayling's legacy and justice from personal friends and state-licensed workers I employ upon the court to help initiate the immediate shut down of all sites slandering & discrediting while threatening my family's safety.

Along with named parties Facebook for not having an actual remedy or avenue to stop false, hateful, and actively harmful & targeted attacks gang cyber stalking and in fact by with billions not having customer service and units set up to handle the attack of a victim of police brutality is absolutely disgusting and beyond dangerous to truth, justice, my family, children, and all others experiencing this on Facebook that ask and seek help with the cyber bullying Facebook is promoting and allowing.

I am seeking immediate protection orders to begin removing all false information damaging to our family's future being spread by state licensed professionals and platforms groups Facebook promoting supporting and allowing ...
