A. June 27th, 2019 THE ARIZONA DEPARTMENT OF CHILD SAFETY, et received notice that my case was to proceed in the ninth district court of appeals. On June 28th a grand jury of three was held to indict me on trumped up false criminal charges. I was not arrested until July 12th, 2019.

B. During my "Arrest" on facebook live on July 12th, 2019, the Deputy Sheriff Edwards Arrest officer number# S1866 stated that he did not have to show me a valid warrant or court order (prior to my unlawful arrest). I Asked on live video for three forms of proper identification from this officer and he refused to also show me proper identification. The Police Department Under title 18 : 241 and 242, first represented themselves as "DCS process Servers" Then when they were asked to promptly leave my private property, they then revealed themselves to be from the Sheriffs Department.

C. Their "Authority" to unlawfully arrest me was that I "Identified myself to the officer by opening my window and not because they had a valid warrant or reason for my unlawful arrest. Which no Valid ink stamped Warrant nor valid Court order was shown upon my unlawful arrest. The arresting Deputy Sheriff kept stating over and over a thirty minute period on live video that he did not have to show me a valid court order or a valid Warrant and his identification. As well as he would not state what exactly I was being charged for and that he also did not have to tell me the charge. I was neither briefed nor read my Miranda rights upon my unlawful arrest. The only reason why I went outside peacefully to talk to the officers, because my stepson was in the house and he did not need to be traumatized with them threatening (on live video), to bust down my door using force to gain unlawful entry into my home.

D. However, When I stepped outside to talk peacefully with the officers they pulled me out of my home to the ground with my face down with their guns drawn threatening to shoot me. With excessive force they double handcuffed me with an officer's foot on the back of my neck threatening to shoot me if I moved. I was then taken to an exchange point (a mortuary), Under a gravesite canopy the law enforcement was giving me glances and a subliminal message. This is not normal Protocol they should have taken me straight to the jail. Yet I was driven around in circles in an unmarked car in Maricopa County only to exchange to take me to the Jail and the exchange point was a mortuary these people operating the Color of law seem to stop at nothing to retaliate against me or be held under any accountability what is next finding my name in the obituary column for wanting my son JD:Z rightfully returned to me? God forbid, this needs to be resolved immediately in my jurisdiction.

E. On the 13th of July , early in the morning before Judge J. Fish they did not release me of my own recognize. Even though J. Fish state there were no previous history of any misdemeanors or felonies . THE STATE OF ARIZONA placed a 25,000 dollar bond for my release in regards to their trumped up charges . This Judge also could not even tell me What I was being charged for . THE STATE OF ARIZONA cannot even document who I allegedly injured nor can they document whether it is a misdemeanor or felony . Please Note: The Bondman from Bails bonds USA waived the 25,000 dollar collateral due to the fact he thoroughly checked my background and found no previous criminal charges that I had no business being incarcerated in the worst jail in the nation. Who can be called into testify if necessary .

All this in essence is the Respondent's retaliation against I , a loving mother in attempts to spitefully keep me from seeking justice in my jurisdiction . Therefore respectfully I demand resolve in my jurisdiction against the Respondents and the rightful return of my son JD:Z back into my safe and loving care where he truly belongs .

For the Record , all submitted documentation shows retaliation from the STATE OF ARIZONA against I , a loving mother and my son for ten months all from one retaliatory phone call made from Banner Medical Center for wanting to confirm as a loving mother , Dr. Husam Mullah's medical diagnosis of Chrons and Colitis seeing my son JD;Z was misdiagnosed by Phoenix Children's Hospital in the past see all medical documentation attached.
