Motion request for An immediate Federal Protective order for myself, Lee Kenworthy, Siabella + Mikailan Kenworthy to reunify and end the ongoing illegal detainment for protection of all defendants + conspiring pointless crimes to go unabated.  
regarding case number 2:18-cv-12822 Kenworthy vs Lyndhurst

Robert Martin for 45 minutes threatened my family our children our lives and future recordings submitted meeting clear and convincing standards of evidence proof as it's highly likely that it's true actually doesn't even apply to the level of proof hearing Robert Martin saying he will make our lives hell if we do not comply with his illegal actions he's a federal marshal who will chase/hunt us down if we do not do illegally as we are being threatened to do with his weapon out in use to further intimidate hinder our lives ... Detective Pizzuti again recorded threatening the Kenworthy family for recordings of crimes committed as detective Pizzuti obstructs justice tampering with evidence would again put us into clear and convincing evidence that Lyndhurst police officers aided in Roberts threats unlawful detainment cruel and unusual punishment and his continued lack of prosecution while the Kenworthy family is held responsible for their crimes against our family shows loud and clear justice has a long way to go to even scratch the surface of equality fair and just cause those are privileged civil rights just at this point words my family has yet to experience...

Robert Martin Lyndhurst police and Dcpp even after exacting their agenda & threats upon us we have gone thru another 3 years of Robert Martin Lyndhurst police Dcpp and attorneys coming into our homes lives and now literally smacking my children across the face saying keep your little trash spic mouths shut about what I/we did to your family if you ever want to go home This statement is being made because Lyndhurst police officers and a few other parties involved made these exact comments of keep my spic Shayling on a leash where pets animals belong before she gets bite!!!! Now I ask why are my

half breeds also stated by parties involved being leashed is that the next exaction of revenge control to keep this me us quite ...

This daily states as has also been boldly stated No police officer is ever going to take a report and arrest any actual guilty party and I'll make sure since your family father couldn't be paid off your shut up and if he doesn't do as told like Dcpp threatened for multiple parties all defendants they'll adopt your 1st generation asses to your republican grandparents cheering on a wall to kick out your mothers kind and guess who they just so happen to be friends with Robert Martin as well as multiple officers with pull to do so ...

After the 1st lawyer Bryan Dratch did in fact break the law misrepresenting us never initiating discovery misfiling not naming Lyndhurst Chief and Dcpp putting us in harms way leaving us retaliated against and fully complicit in not properly presenting the crimes of Robert Martin and Lyndhurst police officers and their entire departments violations against our civil rights 4th cruel and beyond unusual punishment which is ongoing until this is finally brought to an end thru truth and full illustrations of crimes against Siabella and Mikailin and our family.

The lack of care and concern for life shown by all from police to advocates to reporters lawyers judges there is no value on anyone's life no care for rule of law concern for safety or tomorrow. We as a nation are truly lost and the world is not better for or from our example it's our lack of concern that is choking the world while we continue allowing criminality everywhere never charging true crimes leaving the elitist ruling class to enjoy undressing children taking pics for their menus as to which families should be ripped apart for profit personal enjoyment and gain good part that for profit souls for sale component is there you know that compels and motives the worst in people and corruption to run rampant especially when unabated or checked even by our federal court processes and prosecutors

I ask that the court given all factors of misrepresentation demand discovery especially on the body cameras Shayling Kenworthy was killed on by officers hagerty and Riena and the 911 call recordings which have Shayling and I answering the door to the police officers and not an ambulance as the ambulance sat outside dashboard cams as well then Shayling spoke another 2

minutes before getting off the recorded line fully illustrating Lyndhurst police willingness to lie cover up murder and their continued threats upon my family which I'd also ask the court to request require Lyndhurst police departments full written explanations as to why to this day Robert Martin has not been charged by them and when he will be for threatening our family with his weapon witnessed by Siabella Mikailin Shayling and fully reported to Lyndhurst police weeks before their officers ended her life. His position as a law enforcement chief he knows exactly what his threats and actions set in motion as does any and every party seeing the evidence they just don't want to accept he is actually that big of a piece of shit bringing into question his career along with all officers from Lyndhurst who are involved in this both then and ongoing ...

I would also ask for written explanation when officers hagerty and Riena will be relieved of duty fully investigated and prosecuted as the fbi press relations department is now recorded stating they apologized that has yet to occur and our family is enduring any retaliation for these criminals to continue getting away with disregarding their badge duty and integrity... The fbi will be since she's now been made aware of all surrounding corruption fully prosecuting all guilty parties still engaging in willfully breaking the law threatening and attacking my children and family for their protection..

Also please explain Detective Pizzuti still on duty not prosecuted after threatening me following Shaylings murder which shows their/Lyndhurst police officers and departments full intent to continue harming my family and children violating our 4th amendment inflicting upon my family a torture we do not deserve for their crimes ongoing trying to avoid responsibility.. when actions are recorded being ignored by all ... unless I'm wrong please retort as to lack of prosecutorial misconduct charges or actions and explain how Roberts threats weren't that and your officers willful misrepresentation of facts when they say Shayling was down contrary to 911 evidence ie they murdered her and altered reports unless that is not a few crimes and fully illustrating there's something to hide in this equation when if they are honorable officers let's all watch the body cameras as stated by earlier officers who responded to the house that night of they are wearing them they are on no choice 1 full stream ..

My daughter will upon deposition again detail Roberts threats with his weapon detail Lyndhurst police false arrest threatening her and Shayling and all

unlawfully detaining is with their threats and follow thru of Roberts threats Siabella will also confirm and add about Gutenberg officer Richard Anderson telling her about the carpets being down since and some of the urine aside from being pets cats dogs came from his brother in law Bobby Jr when he was a child waking up scared and peeing all over the carpet ...:

1: the reason Bobby jr was scared was surrounding his father hitting him  
:2: These are police officers knowing the law and a home being rented government subsidized approved that has not removed replaced cleaned or remedied the urine of 20+ years on the carpets that by law renting must be replaced every so many years and beyond common decency and integrity keeping us by threats in these circumstances is beyond cruel and beyond unusual punishment

These details were told to Dcpp by Shayling myself and both Siabella and Mikailin along with giving them the evidence yet Dcpp who also is recorded sexually assaulting both children instead followed thru also with Roberts threats and has since illegally for all parties protection taken illegal custody of our entire family directly conflicting interests especially given all new subsequent evidence to be transcribed and introduced immediately.. the crimes committed against us can not be allowed another day as the harm trauma being caused is beyond irreparable it's cruel and unusual for the federal court to allow another second of it for protection of crimes against our family it's an affront to watch or allow and support it with any further inaction

It's with these factors and the state Dcpp working again with multiple parties to protect their actions crimes and liabilities against our family my children must be in my full custody protected federally against all private corporations involved hindering their rights freedoms and ability to even speak about their mother crimes witnessed and ongoing against them and myself ....

To try and utilize illegal records paid for by them they wish to legally state again which contradicts and conflicts with my actual medical records and it being closed litigation because of a medical doctor stating actual mental health Ie actual legal medical records history thereby making every action beyond illegal with intent for protecting their liabilities this is nothing but cruel and unusual punishment to my children family for protection of those who actually

in fact have committed crimes against our family From threatening to sexual assault and witness tampering threatening adoption if I continue pursuit of justice for Shayling and children yet my children and I are being punished further and ongoing so these criminals can continue walking fully free while the federal court continues to allow us the Kenworthy family being tortured truly tortured I ask immediately this issue be addressed with an on camera in chambers conference in lieu of formal proceedings rule 16 conference discovery commencement and conferences with my family finally reunited and not being retaliated against in any way that would be excellent and so appreciated hopefully your honors can humble provide that protection for us it would be beyond appreciated

Also my children need to be brought with their our current therapist to freely speak safely finally without intimidation so your honors can hear loud and clear there is no reason my children were taken and no reason to keep them from safety love and nourishment of full personality soul and spirit allowed to talk about their mother freely how she was killed and be getting therapy for what we actually have been thru not what Dcpp is claiming therapy while they continue protecting liabilities of crimes committed against Siabella and Mikailin and our family.

Siabella stating recently this is all 4 noting which is absolutely true it's for protection of criminals that took her our life that's what she's gonna discuss for life in therapy not if daddy made her do the videos and how sick her father is and how her mother left her because she's a drug addict like is being allowed to be spread online freely by parties who connect back to Lyndhurst police department and Robert Martins personal friends ...

Motions to dismiss as they are procedurally out of order given a rule 16 conference should have commenced before discovery or motions to dismiss So diligently pointed out by counsel trying to bully a pro S.E. plaintiff for going into a second year when all liabilities are fully exposed as to every defendant named ...

Robert Martin retired deputy chief of police of Jersey City is recorded threatening our lives safety to remain in unhealthy unfit conditions with his weapon present out forever scarring our children who watched this cop get away with breaking the law and then went on to watch Lyndhurst police

officers help Robert break the law unlawfully detaining us keeping us in unfit conditions threatening their/our safety resulting in the murder of their mother Shayling Kenworthy

All submissions of recorded evidence fully illustrates both jurisdictions and constitutional civil rights 4th amendment violations amongst other crimes committed by defendants fully demanding the case go to trial as validity burden of prof has been fully meet and demonstrated...

When the amended complaint was submitted it was specifically submitted in Trenton to include the recordings evidence of crimes that Newark's office would not include in original complaint ...

Within the complaint the recordings and their 4th amendment violations crimes including Robert Martin threatening our family our lives with his weapon out present taking it to the degree of either impersonation of a federal official Marshal or abuse of power position and authority when stating if we didn't do as he was illegally intimidating my family to do pay him months of rent not owed saying we must stay living there falsely detaining is or he would cause false arrests detainment and put our kids at jeopardy which Lyndhurst police officers did exactly as threatened by Robert Martin which is fully illustrated by detective Richard Pizzutis threats of a false charge upon Lee Kenworthy the day after officers hagerty and Riena killed Shayling Kenworthy on their body cameras which he confirmed having logged in stating falsely illegally while evidence tampering that the recordings of Robert Martins crimes are illegal because Robert was unaware he was being recorded while breaking the law threatening my families lives ... Now unless the court and federal judges are prepared to tell Siabella Mikailin the world and country a home owner is allowed to impersonate a federal marshal brandish his gun to further intimidate a family children mother father into accepting his illegal unlawful criminal violations of our 4th amendment rights and Lyndhurst police officers and Dcpp following thru on Roberts threats are actually allowed to act like the bloods latin Kings or mafia I believe it's time we get this case on course for justice being served to those who need to accept accountability once and for all while my children have a childhood left ...,

As such recordings being submitted evidence with the courts responsibility being viewing evidence validity of case Ie recorded evidence of police officers breaking the law violations against a family which is/has been submitted

burden of proof to proceed to trial has absolutely beyond been established and illustrated and any further ignorance of such is not willful but in fact further violations against my family and justice ...

I ask this case immediately be put on proper course no further frivolous delaying intimidating tactics by defense be allowed when discovery will result in Lyndhurst officers hagerty and Rienas absolution for the murder of Shayling Kenworthy or final nails in evidence burden of proof already established as to federal constitutional civil rights violations jurisdiction and in fact crimes enough yo fully prosecute which is coming as truth prevails and evidence tampering is more crimes which I would hope at this point officers hagerty and Riena do the honorable thing and don't take anymore people down with you for your heartless callous actions taking Shayling from us...

No homeowner has a right to threaten a family to remain in unfit unhealthy conditions nor does a police department have a right to act as a gang against a family for a homeowners or private corporations agenda ... Unlawfully detaining a family to their whim control and ultimately exactly what Robert Martin threatened one of us in the grave our lives a living hell ... This is way beyond cruel and unusual punishment my family is begging and demanding end immediately especially being in the control of judges such as yourselves fully aware of accountability acceptance and integrity...

Again for full reiteration and illustration of absolute irreparable harm another day of this upon my children Siabella and Mikailin is beyond immoral and needs to be immediately addressed as it's clear and present witness tampering illegally detaining for protection of crimes committed against by exact agency being allowed to illegal detain my minors in their custody for their benefit and protection demanding the federal courts immediate attention and addressing unless again the court is compromised and a willing participant cause at this point ignorance of evidence submitted cannot be carried into tomorrow when it's obvious and apparent if these actions were taken by gang members my family would not be begging for humanity and decency in the letter of the law being so willful ignored ...

Detective Pizzuti stating illegally that the evidence of Robert Martin violating our civil rights threatening our lives unlawfully detaining my entire family in unhealthy unfit uninhabitable living conditions that was affecting our health life finances and ultimately because of Robert Martin Lyndhurst police

departments and Dcpps willing engagement of follow thru on Roberts threats our actual ability to move freely as citizens with constitutional rights as fully shown again by Lyndhurst detective Pizzuti when he again choose to break the law tamper with evidence threatened the victim of the violent crime Robert Martin committed with his weapon present out and in use to threaten and intimidate my family wife children and myself unlawful detainment terroristic threats of violence and death and removal of our children which Dcpp instead of protecting our families safety they followed Roberts threats ...

This is beyond cruel and unusual punishment which was exacted against my children wife and family with deliberate intent as illustrated by Lyndhurst police officers further actions not prosecuting or protecting Siabella and Mikailin Kenworthy who are also victims to police brutality and corruption as this continues for officers Dcpp and homeowners to not accept any accountability my family is continuing to be punished for their illegal civil rights violations and crimes against our family and Shayling Kenworthy resulting in her murder on body camera as again Pizzuti acknowledges they are logged in as is the 911 call Shayling Kenworthy is alive and well on fully again illustrating burden of evidence proof beyond a properdernce that Lyndhurst police officers hagerty and Riena lied about Shaylings actual condition Ie being alive on her feet responsive and talking to both them the 911 operator and myself fully illustrating evidence chains are being altered fabricated and illicit actions are being protected ... When the Bergen county prosecutor stated illegally also after seeing the body cameras hearing the 911 call Shayling Kenworthy alive on them not down as fabricated by her murderers that he is now a witness in the lawsuit taking me for a Moran/idiot who's aloof to the law and procedures of law as the prosecutor it's his/her job to fully prosecute those police officers who threatened my children family wife and those officers who lied on their police reports to protect their illegal actions of denying Shayling Kenworthy oxygen saving her life thereby murdering her deliberately with intent as illustrated by all subsequent illegal actions reports statements and threats like Pizzutis of arresting lee Kenworthy who recorded crimes against his family with his wife and children to protect ourselves from criminals behind the badge and in 3rd party state positions of authority who are blatantly misusing that power for profit gain and protection ...
