[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On 9/25/19 I responded to a burglary in progress call. While driving to the call I observed a male, later identified as Shawn Stuller (w/m DOB: 12/17/88) walking north on Redfish Point Rd at the intersection of Redfish Point Rd and Oakhill Rd. approximately a block away from where the burglary occurred. Shawn matched the description given by dispatch for the suspect: white male, 6ft, beard, no shirt, cargo shorts. As I exited my marked patrol car, Shawn spontaneously uttered "I didn't steal anything!"

I detained Shawn and advised him of his Miranda rights from a department issued card. Shawn waived his right to have a lawyer present and agreed to speak to me. Shawn stated, he was sorry for going into their car and he would make it right if they would not press charges against him. When asked what he took, Shawn stated some change and some DVD's.

Shawn provided a detailed description of the DVD cases, one was a black leather type fabric case. The other was a red and black case that resembled a lady bug. The cases contained 50 DVD's each. Each DVD was valued at \$25 and each case was valued at \$10. The total value was \$2520.

Shawn provided the location of where he hid the cases. He stated, go through the fence gate around the side of the house to the back yard, next to the bicycles. Both cases and all DVD's were recovered and returned to the victim. Shawn had to open the closed gate in order to enter the back yard.

A show up identification was conducted, the victim positively identified Shawn as the individual he had seen in his vehicle.

Due to the statements provided, I arrested Shawn and placed him into my marked patrol car. I transported Shawn to the Santa Rosa County Jail.


During the intake process, a round, blue, pill, with 972 stamped on it was discovered in Shawn's wallet by detention staff. The pill was positively identified as AMPHETAMINE & DEXTROAMPHETAMINE 10mg by the Physician's Desk Reference. It is classified as a Schedule 2 controlled substance under the Controlled Substance Act. The pill was submitted to evidence.

- Shawn was charged with one count each of:
- 810.02.4b - Burglary unoccupied conveyance - bond \$7,500
- 812.014.2c1 - Grand theft over \$300 less than \$5,000 - bond \$7,500
- 893.13.6a - Poss of controlled substance with out prescription - bond \$7,500
- 810.09.2a - Trespassing - bond \$500

Shawn was given a total bond of \$23,000.00 and released to the detention staff.

This occurred in Santa Rosa County, Florida.

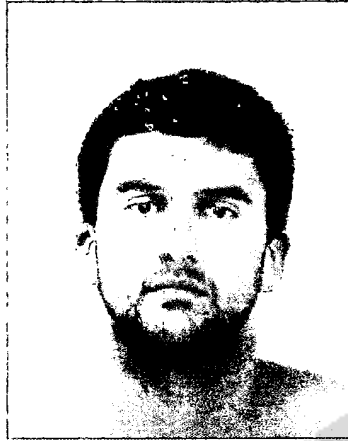

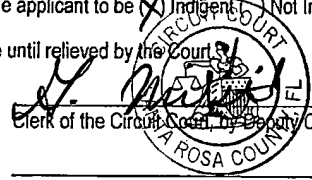


