Dear Judge Dickson:

As Your Honor knows, this office represents Defendants Robert Martin, Ann Martin, Richard Anderson and Lauren Anderson in this action. Mr. Anderson is an officer of the Guttenberg, New Jersey Police Department.

It has come to my attention that on October 24 and 25, 2019, Plaintiff Lee Kenworthy made a number of telephone calls to the headquarters of Guttenberg Police Department attempting to speak to my client Mr. Anderson. See Exhibits "A" through "D" forwarded to me by my client. The Investigative Report regarding the calls characterized Plaintiff's conduct as constituting Harassment in violation of *N.J.S.A. 2C:33-4* and Terroristic Threats in violation of *N.J.S.A. 2C:12-3*. See Exhibit "A", Page 1 of 2. It indicates that Plaintiff made "remarks over the phone that could be taken as threats of violence." See *ibid*. At least one of the telephone calls made by Plaintiff related to his "complaint" against Mr. Anderson (see Exhibit "B"), presumably his complaint in this action

N.J. RPC 4.2 prohibits an attorney from contacting a party when the attorney knows the party is represented by counsel regarding the subject matter of the representation. There is no

reason why the prohibition should not be binding on a *pro se* litigant. Prohibiting Plaintiff from contacting my clients is especially appropriate here in light Plaintiff's threatening conduct as evidenced by the attached reports.

Therefore, I respectfully request that the Court order or admonish Plaintiff that he is to have no contact with Defendants Robert Martin, Ann Martin, Richard Anderson and Lauren Anderson and members of their families.

I thank Your Honor for the Court's attention to this matter.
