[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

CAD INCIDENT DISPOSITION CODE: [87-0][A][3][]

On 01/10/20, Shawn Stuller did knowingly and intentionally at 21 Via De Luna Drive (Paradise Inn) in Escambia County, Florida, commit the offense of trespass after warning. The facts and circumstances are as follows:

On 01/10/20, I responded to 21 Via De Luna Drive (Paradise Inn) in reference to a trespass complaint. Upon arrival, I made contact with RP/Karl Hedlund the night manager who was placed under oath and gave the following statement. RP/Hedlund advised that a guest of Room 117, was recognized as someone who had been trespassed several months ago from Paradise Inn. RP/Hedlund indicated that the guest he knew as "Shawn" was waiting in front of the main office. RP/Hedlund described him as a white male wearing blue jeans and a long sleeve white tee shirt.

I then proceeded to the main office where I observed a white male later identified as S/Shawn Stuller matching the description provided by RP/Hedlund.

I made contact with S/Stuller and asked if he was staying at the hotel. S/Stuller stated he was staying with his uncle in Room 117. S/Stuller stated the room was in his uncle's name and I requested S/Stuller's ID to confirm the trespass warning. S/Stuller stated that he had no ID with him, but provided the name of "Shawn Thomas Stuller with a date of birth of 12/17/88."

A subsequent check through dispatch revealed an active trespass warning on 05/22/19. S/Stuller was advised there was an active trespass warning from Paradise Inn that had been issued on 05/22/19. S/Stuller stated he knew he had been told to stay away from the property, but that he thought it was only for six months.

RP/Hedlund was given a business card and case number.

S/Stuller was taken into custody and transported to the Escambia County Jail, where he was charged with trespass after warning with a bond of \$500. S/Stuller was given a County Court date of 01/30/20.

No known video.

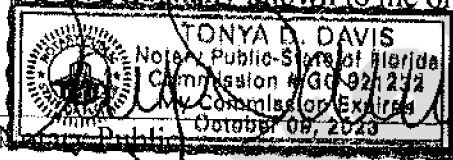
AFFIDAVIT
