On October 9, 2020, Defendants Kids Behavioral Health of Montana d/b/a Acadia Montana (“Acadia”) and Jennifer Hedke (“Ms. Hedke”), moved this Court for a more definite statement pursuant to Federal Rule of Civil Procedure 12(e).
