evidence, the high volume of records, and number of witnesses. The charges in this matter follow lengthy Juvenile Court proceedings that took place over several years. The Court has conducted regular status and complex case management conferences. During these conferences, Defense counsel has kept the Court and parties apprised of the status of discovery and case preparation — that preparing Defendant's defenses requires that counsel read and understand voluminous court, medical, and DCS documents before interviews, particularly of medical witnesses, can be conducted. Today defense counsel advises that he has reviewed additional documents since the last hearing, however interviews have not yet been scheduled and the matter is not ready for trial. He is identifying possible gaps in records and will communicate any such issues to the State.

Discussion is held regarding Defense counsel's Motion to Continue trial. Counsel for the State and victims do not oppose the Motion. Defendant objects to a continuance and makes an oral motion that her counsel withdraw. The Court takes no action on the oral motion. A motion for change of counsel must be filed in writing.

Having considered the Motion to Continue by counsel for the Defense, the Court finds a continuance indispensable to the interests of justice and extraordinary circumstances warrant the continuance and exclusion of time. The Court has considered Ariz. R. Crim. Proc. 8.1, Local Rule 2.2, applicable Administrative Orders regarding trials, and ARS 13-3961(E). The extraordinary circumstances are:

Defense counsel requires additional time to complete his review of discovery (which includes voluminous, technical documentation, in order to prepare a defense.

The presence of COVID-19 in the community (and especially high infection numbers currently) mandate the prioritization of jury trials. The Court considers that Defendant is out of custody and the backlog of in-custody defendant awaiting trial.

IT IS ORDERED vacating the current trial setting of 01/19/2021 and resetting same to 05/13/2021 at 11:00 a.m. before the Master Calendar Assignment Judge. The Trial Assignment hearing will be a Court Connect videoconference held using the Microsoft Teams platform. The purpose of the hearing is to set future dates for (1) the Trial Procedure Conference, (2) the Trial Status Conference, and (3) the Firm Trial Date.

The Court waives the presence of any defendant represented by an attorney at the Trial Assignment hearing. Self-represented litigants shall appear by videoconference following the directions below. If a self-represented litigant is in custody at the time of the Final Trial Management Conference (FTMC), this division will notify the Assignment Judge's division so that the defendant can be transported to CCB 902 to participate in the videoconference.
