On March 17, 2021 while performing my assigned duties as the Facility Inspector at Santa Rosa County Jail I was notified of an incident involving an inmate physically grabbing a Deputy Sheriff during the performance of her duties, and her request for formal action taken in response. The following narrative details the circumstances surrounding this incident

On March 16, 2021 at 7:15pm while conducting an inmate count in the DSU-1 housing area of the Santa Rosa County Jail, Deputy C. Benson ordered Inmate Stuller, Shawn to give her his jail issued inmate Id card multiple times. Following her last order Inmate Stuller then, while laying down on his assigned bunk, extended his arm with the Id card held tightly in his hand. As Deputy Benson took the ID card from his hand, Inmate Stuller released the ID card, quickly grabbed her hand, and attempted to pull her towards him. Deputy Benson immediately broke free of his grasp and established distance between herself and Inmate Stuller. Deputy Benson then secured Inmate Stuller in an interview/holding room without further incident. It was later determined by the on-duty Shift Supervisor to initiate procedural security enhancements on the housing and management of Inmate Stuller due to his physical aggression toward detention staff. A copy of Deputy Benson's Incident Report # SRSO21JIN000912 will be attached as a supplemental narrative for review. In addition, a digital copy of the fixed wing video footage of this incident will be burned to disc and secured into evidence.

By his actions in the above detailed incident, Shawn Stuller did knowingly and willfully violate Florida State Statute 784.07.2b Battery on Law Enforcement Officer.




