- Public Defender Rick Tosto is refusing to submit exculpatory evidence and subpoena 3 professional witnesses and several character witnesses.
- Judge Fish has sealed all exculpatory evidence that proves my innocence.
- The Originating Phoenix Police Report that is being swept under the rug, proves that it was not a Picc-Line that I am accused by AZ prosecutors that I allegedly removed but an IV I unscrewed due to my [REDACTED] being tangled in the IV line so [REDACTED] could go to the bathroom. I called the nurse 3 times with no response. The nurse came back and reconnected the IV line.
- I have recordings of doctors that Judge Fish sealed that exhorates me and reveals the truth about my [REDACTED] condition which was misdiagnosed December of 2016 and January 2018 and all the emergency visits in between by Phoenix Children's Hospitals doctors and staff.
- Audio recordings that show [REDACTED] arrived at PCH. However, my [REDACTED] [REDACTED] Clearly, documented by South West Human Development visitation notes. It is also documented on the Glendale Police Report that my [REDACTED] [REDACTED]
- Dr. Husam Mullah from Banner Thunderbird Children Center [REDACTED] as firstline treatment and I simply wanted to take my [REDACTED] and confirm Dr. Mullah's diagnosis to his PCP provider. Dr. Mullah stated on the audio that most parents have hesitation to give their children [REDACTED] and that is a normal reaction for parents.

- The next day, on September 6th 2018 I, Arlena Willes, set up an appointment with my [REDACTED] PCP provider for the 19th of September. With two referrals to a [REDACTED] I was not given the chance to confirm Dr. Mullah's diagnosis for that same day, two AZ DCS social workers showed up at my door, Olivia Douma and Sabrin Tawil. They demanded me to take [REDACTED] to PCH even after I told them I had an appointment with his PCP provider and I would take [REDACTED] back to the hospital ER if necessary.
- Dr. Mullah stated in the audio that I complied with all methods of treatment except the steroids and he was shocked that Dr. Kristy Ingebo did not follow through with his recommendation of treatment.
- On the audio Dr. Kristy Ingebo pushes for criminal charges on me and LIES to EVERYONE making Detective Christine Britt believe she [REDACTED] among many other untruths that have been sealed from public record. Also, Dr. Ingebo said that my [REDACTED] [REDACTED] at PCH.
- I have a PCH Medical Document dated September 7th, 2018 stated that my [REDACTED] was sitting in a wheelchair pleasantly chatting with anyone within [REDACTED] perimeter. Therefore, this document proves my [REDACTED] was not [REDACTED] as Dr. Ingebo claims.
- Banner Hospital Medical Record states on September the 5th, 2018 that my [REDACTED] was not in any imminent danger, there was [REDACTED] [REDACTED]
- Dr. Ingebo on audio laughing stated that she wanted to go and tell my [REDACTED] that [REDACTED] mother's rights are going to be severed and [REDACTED] would never see [REDACTED] mother again!

- There is documentation to prove [REDACTED] as Dr. Ingebo led everyone to believe. Dr. Ingebo stated in Europe formula is the first line of method of treatment for [REDACTED] Yet, Dr. Mullah and Dr. Hayes states that steroids are the first line of treatment for [REDACTED] Then, Why wasn't steroids used? And why was Dr. Mullah's recommendation not administered by Dr. Ingebo? Instead she resorted to an aggressive method of treatment by [REDACTED] [REDACTED] as Dr. Ingebo led everyone to believe.
- Dr. Ingebo also led everyone to believe that she diagnosed my [REDACTED] with [REDACTED]. Then she states, on audio, that in retrospect she didn't know what [REDACTED] had, contradicting herself on audio recordings. My [REDACTED] was not diagnosed with [REDACTED] until September 2nd, 2018 by Dr. Mullah.
- Dr. Ingebo gave my [REDACTED]
- This proven evidence enclosed has been released to the public and social media on a video interview and the Prosecutors Tracy Gleason & Frankie Grimsman motioned Judge Fish to seal all my evidence that proves my innocence. Judge Fish granted their motion and then the heat was on for me to take a plea-bargain. Four different times they tried to pressure me with four levels of pleas.
- When I refused each time the last plea was reduced from two class 2 felonies to two class 6 felonies with no jail time with probation.
- When I told them I would not plead guilty to child abuse, aggravated assault and endangerment, Frankie Grimsman asked me if there was anything I would take a plea with? This is a tall tale sign that they know perfectly well that I am innocent!

For this cause, I am petitioning the court for a continuance, change of counsel due to ineffective counsel and unsealing all evidence that pertains to my innocence.
