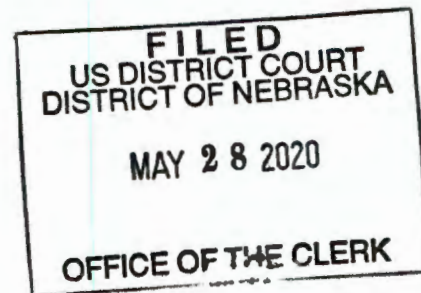

2. Notice - Thomas W. Hird , hereinafter as ‘Respondent’, as a man, not wishing to take on the liability of a U.S. ‘person’ as the term ‘defendant’ is defined in United State written law.
3. Notice – no evidence exists that the man, Thomas W.Hird, has ever elected to contract with the UNITED STATES OF AMERICA.
4. NOTICE TO JURY - This is the second attempt for the identical discoverable evidence, the first was inadvertently under Civil Rule 26, as Hird is not an attorney.

10. Respondent has not received any ‘Initial Disclosure’ from the Plaintiff at this time, and wishes for the Plaintiff to provide immediately, pursuant to all Rule 26, giving specific attention to the underlined portion provided in the said Rule 26, as posted below.

11. In addition to the above the Respondent needs the following: As stated in Rule 16 (1)(E).

- a. That Plaintiff provide all relied upon documents, for any and all alleged tax debt , and the name and contact address for the man* that can verify* the accuracy, reliability, and correctness of all that is relied upon. (The term man* & verify*, are both defined at the base of this document and is to be so defined when used anywhere in this document.)
- b. That Plaintiff provide all relied upon assessments for all years, related to each individual charge of COUNTS 1, 2, 3, 4, and 5, which Plaintiff is claiming due, and the name and contact address for the man that can verify the accuracy, reliability, and correctness of all

that is relied upon.

- c. That Plaintiff provide all relied upon certified, or verified, accountings, from any man, that gathered any figures, and any accountings, of any itemizations, of any relied upon assessments, including penalties and interest, and the name and contact address for the man that can verify the accuracy, reliability, and correctness of all that is relied upon.
- d. That Plaintiff provide all accounting formulae, gui delines, and applicable policies, supplied to the individuals, making any accountings/assessments, that the Plaintiff relies upon, as to Respondents duty to file, and money obligation to pay, and the name and contact address for the man that can verify the accuracy, reliability, and correctness of all that is relied upon.
- e. That Plaintiff provide all evidence that Plaintiff relies upon, that Respondent had any contract with the Plaintiff, and the name and contact address for the man that can verify the accuracy, reliability, and correctness of all that is relied associated with any claim of contract between the Plaintiff and Respondent.
- f. That Plaintiff provide all evidence that Plaintiff relies upon, that Respondent had any business contact with the Plaintiff, and the name and contact address for the man that can verify the accuracy, reliability, and correctness of all that is relied upon as associated with any claim of contract.
- g. That Plaintiff provide all evidence that Plaintiff relies upon, that Respondent had any income earned in land of 'The United States of America', or had earnings, in any land that is of the Plaintiff, and the name and contact address for the man that can verify the accuracy, reliability, and correctness of all that is relied upon associated with any said claim of income earned.
- h. That Plaintiff provide all evidence that Plaintiff relies upon, that Respondent had any business activity in land that is of the Plaintiff, and the name and contact address for the man that can verify the accuracy, reliability, and correctness of all that is relied upon as to any claim of activity in land of 'The United States of America', or the Plaintiff's land.
- i. That Plaintiff provide all evidence that Plaintiff relies upon, that Respondent had any nexus with the Plaintiff, and the name and contact address for the man that can verify the accuracy, reliability, and correctness of all that is relied upon for any nexus between Plaintiff and Defendant.
- j. That Plaintiff provide all evidence that Plaintiff relies upon, that Respondent had any business activity in land that is of the same type of land as described, or identified, in Article 1, Section 8, Paragraph 17, of the 'Constitution for the United States of America', and the name and contact address for the man that can verify the accuracy, reliability, and correctness of all that is relied upon for such claim of any activity in the described land.
- k. That Plaintiff provide all documents, or any evidence, that Plaintiff relies upon that Respondent elected to become a United States citizen, and the name and contact address

for the man that can verify the accuracy, reliability, and correctness of all that is relied upon that supports any claim of citizenship upon Respondent.

- l. That Plaintiff provide all documents, or any evidence, that Plaintiff relies upon that Respondent is a 'person' required to file any form with the Plaintiff, or the IRS, and the name and contact address for the man that can verify the accuracy, reliability, and correctness of all that is relied upon that claims Respondent is such a person.
- m. That Plaintiff provide all documents, or any evidence, that Plaintiff relies upon that Respondent is 'eligible' to file any form with the Plaintiff, or the IRS, and the name and contact address for the man that can verify the accuracy, reliability, and correctness of all that is relied upon for any claim of eligibility.
- n. That Plaintiff provide all documents, or any evidence, that Plaintiff relies upon that Respondent is 'qualified' to file any form with the Plaintiff, or the IRS, and the name and contact address for the man that can verify the accuracy, reliability, and correctness of all that is relied upon as to any claim of being qualified.
- o. That Plaintiff provide all documents, or any evidence, that Plaintiff relies upon that Respondent is a 'person', eligible, or qualified, to possess a Social Security Number, and the name and contact address for the man that can verify the accuracy, reliability, and correctness of all that is relied upon as associated to a SSN.
- p. That Plaintiff provide all documents, or any evidence, that Plaintiff relies upon, that Respondent is a 'person', eligible, or qualified, to file a Form 1040, U.S. Individual Income Tax Return for the tax years listed in the Indictment, and the name and contact address for the man that can verify the accuracy, reliability, and correctness of all that is relied upon as to any claim that Respondent is eligible or qualified.
- q. That Plaintiff provide all documents, or any evidence, that Plaintiff relies upon, that Respondent could, as a matter of law, 'file' Form 1040, U.S. Individual Income Tax Return for the tax years listed in the Indictment, if no evidence exists that Respondent is in fact a 'person', eligible, or qualified, to 'file' a Form 1040, U.S. Individual Income Tax Return, and the name and contact address for the man that can verify the accuracy, reliability, and correctness of all that is relied upon as to this request.
- r. That Plaintiff provide all documents, or any evidence, that Plaintiff relies upon, that Respondent is not entitled, or has no right, to an assessment that is compliant to the written laws of the United States as located at 26USC6203, when such was requested, by mail communications, for each and every year associated with this case, as mailed, as requested in the respective years, and the name and contact address for the man that can verify the accuracy, reliability, and correctness of all that is relied upon that such 6203 assessment is not due to Respondent upon request. (Note **not** one assessment request was ever honored (provided to Respondent) by the Plaintiff, or by the IRS, or any other agency associated with the principal.)
- s. That Plaintiff produce evidence that Plaintiff has law that evidences that Respondent can

be held criminally liable (intent) for doing an act (sending a 1040 Form) that has evidence of being done fully under fear, coercion, and duress, and the name and contact address for the man that can verify the accuracy, reliability, and correctness of all that is relied upon to prove the said intent.

- t. That Plaintiff produce evidence that Plaintiff has law that evidences that Respondent, as a man, of unalienable rights, can be forced to sign a 1040 Form document, under penalties of perjury, against his will, fully under fear, coercion, and duress, that can then later (NOE) be used against him in a criminal setting, and the name and contact address for the man that can verify the accuracy, reliability, and correctness of all that is relied upon to support such force, or duty.
- u. That Plaintiff produce evidence, that Plaintiff has law, that evidences that Respondent, as a man, of unalienable rights, is subject to Title 26, United States Code, and its positive law source as found in United States Stat at Large, and the name and contact address for the man that can verify the accuracy, reliability, and correctness of all that is relied upon as to being subject.
- v. That Plaintiff provide all documents, or any evidence, that Plaintiff relies upon that Respondent is a resident of Kearney, Nebraska, as such is stated in the Indictment, and the name and contact address for the man that can verify the accuracy, reliability, and correctness of all that is relied upon as to such claim of resident, and the name and contact address for the man that can verify the accuracy, reliability, and correctness of all that is relied upon as to the identifying Respondent as a resident.
- w. It is asked that the definition that is relied upon as to the term resident that was used no less than five times by Plaintiff as describing Respondent. And also is the term "resident" as defined in 'U.S. Statutes at Large', by the supremacy clause of the Constitution for the United States of America applicable as to the term resident used in this case, and the name and contact address for the man that can verify the accuracy, reliability, and correctness of all that is relied upon as to the claim of 'resident'.
- x. That Plaintiff provide all documents, or any evidence, that Plaintiff relies, as the definition of 'resident' as such is isdefined in United States Stat at Large, and the name and contact address for the man that can verify the accuracy, reliability, and correctness of all that is relied upon, as to the term resident as used by Plaintiff in the five counts of this case.
- y. That Plaintiff provide all documents, or any evidence, that Plaintiff has in its possession, or has access to, that Respondent did any business in any city, county, or state, of the United States limited land jurisdiction, and the name and contact address for the man that can verify the accuracy, reliability, and correctness of all that is relied upon as to such activity locations.
- z. That Plaintiff provide all documents, or any evidence, that Plaintiff has in its possession, or has access to, that Respondent elected to reside, or be a resident, in any city, county, or

state, of the United States limited land jurisdiction.

- aa. (Evidence of law to aid response - American Banana Co. v. United Fruit Co., - 213 U.S. 347, 356-357 (1909) “...construction of any statute as intended to be confined in its operation and effect to the territorial limits over which the lawmaker has general and legitimate power.”)
- bb. That Plaintiff provide name and contact address for the man that can verify the accuracy, reliability, and correctness of all that is relied upon as any claim of activity in territorial limits of the written law of U.S.C. Title 26.
- cc. That Plaintiff provide all documents, or any evidence, that Plaintiff relies, that Respondent did“ willfully make and subscribe a Form 1040, U.S. Individual Income Tax Return for the tax year 2012, 2013, 2014, and 2015, or any other year, as stated in the Indictment, and the name and contact address for the man that can verify the accuracy, reliability, and correctness of all that is relied upon for evidence of full disclosure as to support willfulness by respondent as to giving Respondents property over to the Plaintiff, if not required by general law apart from consent. (Seeking evidence of contract by/with full disclosure.)
- dd. That Plaintiff provide all documents, or any evidence, that Plaintiff has in its possession, that Respondent received full disclosure, as to the contractual nature of all association (business) with the Plaintiff, or assumed participation created with filing a 1040 ‘Form’ with/of the Plaintiff, and the name and contact address for the man that can verify the accuracy, reliability, and correctness of all that is relied upon for any such claim of contract.
- ee. That Plaintiff provide all documents, or any evidence, that Plaintiff has in its possession, that Federal Reserve Notes (FR Dollars) are taxable, when earned independent of the UNITED STATES, in land that is independent of the UNITED STATES, by payment for services rendered that is independent of the UNITED STATE, and the name and contact address for the man that can verify the accuracy, reliability, and correctness of all that is relied upon that places a duty upon this Respondent to pay any judgment by any United States administrator, or court order.
- ff. That Plaintiff provide all documents, or any evidence, that Plaintiff has in its possession, that a UNITED STATES license has force and effect in land that is not evidenced as being of the UNITED STATES, as identified in the Said Article 1, Section 8, Paragraph 17, of the Constitution for the United States, and the name and contact address for the man that can verify the accuracy, reliability, and correctness of all that is relied upon as associated with any license implied in this case.
- gg. That Plaintiff provide all documents, or any evidence, that Plaintiff has in its possession, that a UNITED STATES license is associated with the Indictment, and the name and contact address for the man that can verify the accuracy, reliability, and correctness of all that is relied upon as to any license.

- hh. That Plaintiff provide all documents, or any evidence, that Plaintiff has in its possession, that a 'verified complaint' is in the 'official record/file' of this case that was relied upon to initiate any U.S. state, or federal, prosecutorial, or Grand Jury, investigation, or inquirers, for a possible indictment, against a man possessing unalienable rights, as such rights are enumerated in the Declaration of Independence, and the name and contact address for the man that can verify the accuracy, reliability, and correctness of all that is relied upon to provide such information.
- ii. That Plaintiff provide all documents, or any evidence, that Plaintiff has in its possession, that a 4th Amendment - 'verified complaint' 'oath or affirmation' is not required to warrant the arrest or seizure of Respondent, and the name and contact address for the man that can verify the accuracy, reliability, and correctness of all that is relied upon by the man that makes such a claim.
- jj. That Plaintiff provide all documents, or any evidence, that Plaintiff has in its possession, that could be considered as exculpatory evidence in Plaintiff's case, and the name and contact address for the man that can verify the accuracy, reliability, and correctness of all that is relied upon that claims no exculpatory evidence exists.
- kk. That Plaintiff provide all names, and addresses, of all men, that are possibly withholding any exculpatory evidence from Respondent, and a description of that evidence that is believed to be possibly exculpatory in nature. (18USC242, 42USC1983)
- ll. That Plaintiff is asked to provide all documented evidence that Respondent, as a man, has no right of independence, from the United States Title 26 written laws, and that Respondent had a legal duty, as a matter of law, facing criminal prosecution, if Respondent did not complete a IRS 1040 Tax Form accurately in the past. That Respondent can be forced to be liable for a form that he was threatened with prison time, late fees, fines, loss of all his property, if he did not complete, sign, and file, with the Plaintiff as an accurate 1040 as to his private earnings independent of the United States of America. What does the Plaintiff rely upon that 'if' Respondent was forced, against his will, against Thomas W. Hird's 5th Amendment right as a man, to submit, under penalties of perjury, in the five years as charged, as times past, and now face criminal prosecution for not fully complying to the forced extortive acts as history repeating - ""He has erected a multitude of New Offices, and sent hither swarms of Officers to harass our people and eat out their substance.".. 1776 Declaration of Independence.

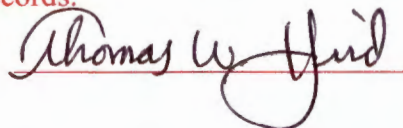
