On the night of June 27, 2002, I was awakened by a stranger forcibly entering my first-floor college apartment. About five hours later, I was a different person. The events that took place in those five hours were the most horrific events I had ever experienced in my 20 years. Five and a half years later, the night my life was marked is still burned impermeably in my mind. I had been raped.

On the afternoon of January 19, 2007, I was sitting in the courtroom of the sentencing of Kent and Jo Hovind during which Judge Casey Rodgers announced that Kent Hovind would spend the next ten years of his life in prison. She stated her sentencing was harsh because the tax-related crimes he committed were worse than committing violent crimes such as murder or rape. The words coming out of her mouth were as bone chilling to me as that unfamiliar touch was on the night my world was turned upside down. Just as vividly as I remember that statement, I remember praying to God that no one in that courtroom would ever be victim of a truly violent crime. No amount of money, regardless of how it was acquired or spent, could ever compare to crimes that were committed against me and my family in those five hours.
