1. This Affidavit is a point-for-point rebuttal to a Summons and Complaint dated August 12, 2022, that was submitted to the United States District Court, Western District of Washington at Seattle, under Cause Number 2:22-cv-01130-TSZ, and received by this Affiant, Glen Stoll, several months later. Additionally, this affidavit is in support of a Foreign Plea in Abatement to the jurisdiction of said court, to the disability of the person of the Plaintiff named therein, to the disability of the person of the Defendant named therein, and to the form of the writ. It is also in support of a Common Law commercial Claim for Damages that this Affidavit accompanies and is incorporated within the above referenced Abatement.

2. The above mentioned Abatement Plea is "Foreign" because the Plaintiff in the above referenced Summons and Complaint has no jurisdiction, no standing, and no cause of action supported by any facts or law upon which relief may be granted to bring its matter before the above named US District Court.

3. The above mentioned Abatement Plea is "Subornation of False Muster" because the Defendant / Obligated Parties named in the Abatement have falsely mustered this Affiant, Glen Stoll, into what appears to be some form of civil or military service under Admiralty and Maritime Jurisdiction of Law, to which this Affiant does not properly belong or lawfully qualify.

4. A "Civil Cover Sheet" that accompanied the Summons and Complaint mentioned in paragraph 1 above, was signed by the first named Defendant / Obligated Party, Dylan Cerling, and apparently on behalf of the other two named Defendant / Obligated Parties Yen Jeannette Tran, and David A. Hubbert.

**REBUTTAL TO THE COMPLAINT**

**5. In rebuttal to the above mentioned Summons and Complaint,** this Affiant, Glen Stoll, incorporates by reference as if fully set forth herein, the attached Exhibit A, being a two page letter dated November 3, 2022 that was filed with the above named court on Friday, November 4, 2022, and served upon the parties as indicated in an Affidavit of Service to be provided by Keith Ellis of Puget Sound Process Service.

**6. In rebuttal to the Complaint, beginning on its page 1, item 1:** The civil action in the above mentioned United States District Court Cause Number 2:22-cv-01130-TSZ was not "timely brought." There are no lawful "outstanding federal tax assessments against Glen A. Stoll," there is no "parcel of improved property" that "is held by a nominee and/or (sic) alter ego of Defendant Glen A. Stoll," there are no valid lawful "federal tax liens on the Subject Property" and, therefore, no lawful "foreclosure," "sale," or "distributing the proceeds of such sale" can lawfully take place.

The undersigned Affiant makes the following Categorical Statement of Fact by this Affidavit:  
(Number each point)

**7. In rebuttal to the Complaint's page 2, item 3:** The "jurisdiction" is hereby being challenged.

**8. In rebuttal to the Complaint's page 2, item 4:** "Glen A. Stoll" does not reside "in this judicial district," there are no such "federal tax liabilities" that have "accrued within this judicial district," and no such "Subject Property is located within the judicial district." See rebuttal paragraph 9 below.

**9. In rebuttal to the Complaint's page 2, item 5:** "Glen A. Stoll" does not reside "in Snohomish County." See rebuttal paragraph 26 below for details.

**10. In rebuttal to the Complaint's page 2, item 6:** Neither "Glen A. Stoll" nor the "Subject Property" are "located in this judicial district," and "Glen A. Stoll" does not have any "unpaid federal tax liabilities" or any "ownership interest in the Subject Property." See attached Exhibits A, B, and D.

**11. In rebuttal to the Complaint's page 2, item 7:** "The Stoll Family Trust" is the current owner of record of "the Subject Property."

**12. In rebuttal to the Complaint's page 4, item 23:** In the Complaint, a statement was quoted from "Article VII of the Restatement of Stoll Family Trust Agreement," at (A)(4). However, they neglected to include a provision of the second paragraph of Article VII (B) "Distribution and Administration of Distribution Trust" that says, "If Glen A. Stoll shall disclaim part or all of the share allocated for him, said disclaimed interest shall be distributed to the Director of the Family Defense League." I expressly did so disclaim in a letter to Janet Spangler, Successor Trustee of the Stoll Family Trust, dated September 28, 2012, wherein I stated, "I disclaim all of the share allocated for me in the Stoll Family Trust Agreement dated the 31st day of January, 1992, Restated the 13th day of September, 2005."

**13. In rebuttal to the Complaint's page 5, item 29:** I, Glen A. Stoll, have never claimed "to have spent considerable time studying the tax laws," nor have I ever made any other similar such claim to anyone, at any time in my life. Even if I had, which I have not, such a claim would be utterly false. Further, I, Glen A. Stoll, have never "made money selling fraudulent tax avoidance schemes to others, using corporations sole and ministerial trusts," nor have I ever made any money doing any other such similar thing, for anyone, at any time in my life. My life's work as a Minister of the Gospel and Church Administrator has never been a source of income for me. It is pure volunteer work for which the Church takes care of my basic needs. See the attached Exhibit A letter that has been incorporated herein. Even if I had in any way been involved in some kind of fraudulent tax avoidance schemes, which I have not, I would not have been able to have "made money selling" them. See Article III of the attached Exhibit F for further explanation.

The undersigned Affiant makes the following Categorical Statement of Fact by this Affidavit:

*(Number each point)*

**14. In rebuttal to the Complaint's page 5, item 30:** I, Glen A. Stoll, did not have any taxable income "for tax years 2001 through 2008" and, therefore, no "income tax liabilities" could have possibly existed during that time for the IRS to have calculated. Any claim made to the contrary would be false, cannot be proven to be true, and would consequently subject anyone making such a false claim on an officially submitted tax return, to the penalty of knowingly filing a false tax return.

**15. In rebuttal to the Complaint's page 5, item 31:** I, Glen A. Stoll, did not receive any such "Statutory Notice of Deficiency" or anything like it "on or about March 6, 2012" or at any other time. There can be no "penalty for failure to file tax return" or "penalty for failure to pay tax" or "penalty for failure to pay estimated tax liability" when there was no income upon which a tax liability could be based. No "time has expired" for me "to contest the Statutory Notice of Deficiency" because no such notice was ever given.

**16. In rebuttal to the Complaint, beginning on its page 5, item 32:** There is no "duly authorized delegate of the Secretary of the Treasury" named to take responsibility for having "made timely assessments against Glen A. Stoll for unpaid federal income taxes." No bona fide assessment has ever been made at all, much less "made timely."

**17. In rebuttal to the Complaint's page 7, item 33:** No such notice "was provided to and made upon Glen A. Stoll" at any time at all, much less "timely notice."

**18. In rebuttal to the Complaint's page 7, item 34:** There was no "demand for payment" ever made, much less any "timely notice," and no such "assessments" were ever provided. Therefore, it would not be possible for me, Glen A. Stoll, to have "neglected, failed, and/or (sic) refused to make full payments of the assessed amounts" as alleged, because nothing of the sort was ever known by me to have even existed.

**19. In rebuttal to the Complaint's page 7, item 35:** I, Glen A. Stoll, do not owe the United States any such amount of money at all. If I did owe any such taxes, which I do not, I would have had an obligation to file a tax return for those years. Willful failure to file a tax return upon obligation to file is a crime, for which I have never been charged because no such crime has ever been committed by me, no such obligation has ever existed of me, and no such taxes were ever due or owing from me, because no taxable income was ever made by me for those years as falsely alleged.

The undersigned Affiant makes the following Categorical Statement of Fact by this Affidavit:

*(Number each point)*

**20. In rebuttal to the Complaint's page 7, item 36:** Thereby, the above named Defendant / Obligated Parties to my Common Law commercial Claim for Damages, Dylan Cerling, Yen Jeannette Tran, and David A. Hubbert have admitted to committing crimes, and possibly other wrongful acts, against me and other members of the Church. They claim to have caused liens to arise, or to have at least been conspiring with others who have caused liens to arise, "in favor the United States on the dates of the assessments set forth in paragraph 32, above, and attached to all property and rights to property of Glen A. Stoll, including the Subject Property." Their "paragraph 32, above" has been rebutted in my paragraph 16, herein above, and elsewhere. For them to have "attached [a lien] to all property and rights to property of Glen A. Stoll, including the Subject Property," as they claim to have done, or at least to have been conspiring with others who have so done, constitutes an admission of their crimes of Conspiracy to Deprive Rights Under Color of Law, Slander of Title, and possibly other crimes, as well as civil or commercial causes of action.

**21. In rebuttal to the Complaint, beginning on its page 7, item 37:** Their act of providing a public "notice to third parties" of the existence of a lien or liens being claimed without having any good faith basis to do so, without notifying the Subject Property owner of record, or without making a good faith attempt to properly notify me as being the named obligated party, constitutes the crime of Maliciously Clouding Title, to which the above named Defendant / Obligated Parties to my Claim for Damages, Dylan Cerling, Yen Jeannette Tran, and David A. Hubbert have thereby confessed to have committed.

**22. In rebuttal to the Complaint's page 8, item 39:** The United States has not lawfully "established a claim against Glen A. Stoll" at any time, for any amount, or for any time period, much less for the specifics that they are alleging here.

**23. In rebuttal to the Complaint's page 9, item 41:** As rebutted in paragraph 12, above, to the Complaint's page 4, item 23, I, Glen A. Stoll, did expressly disclaim "the portion allocated" to me, consistent with paragraph 2 of Article VII (B) of the Restatement of the Stoll Family Trust Agreement.

**24. In rebuttal to the Complaint's page 9, item 42:** I, Glen A. Stoll, have never been the owner of the "Subject Property" at any time.

**25. In rebuttal to the Complaint's page 9, item 44:** The Stoll Family Trust is not and never has been "used as a mere shell to shield Glen A. Stoll's assets from tax collection." I, Glen A. Stoll, have no tax obligation to be collected. Even if I did, which I do not, the current ownership of the Subject Property by the Stoll Family Trust is to assure the perpetual and irrevocable ownership and use of said property for the benefit of the Church and its charitable and religious purposes; never to inure to any private individual.

The undersigned Affiant makes the following Categorical Statement of Fact by this Affidavit:

*(Number each point)*

**26. In rebuttal to the Complaint's page 9, item 45:** Although I, Glen A. Stoll, am currently abiding at the "Subject Property," it has never been my legal residence. "I am allowed and required to live there as a parsonage because of my administrative services to the Church, as long as I am providing said service for the Church." See the attached Exhibit A letter that has been incorporated herein. Legal residence and place of abode are not always the same. That distinction is common with "snowbirds" and students away at college, and is also the case with me as explained more in my Exhibit B and Exhibit D as well.

**27. In rebuttal to the Complaint's page 9, item 46:** The overriding decision that I, Glen A. Stoll, made "with respect to the Subject Property," was to expressly disclaim that portion allocated to me, consistent with paragraph 2 of Article VII (B) of the Restatement of the Stoll Family Trust Agreement.

**28. In rebuttal to the Complaint's page 9, item 47:** It is not true that "Payment of utilities and property taxes is made from the bank accounts of The Director of the Family Defense League," or from any such "a.k.a." as is falsely alleged. All such obligations and payments are made by other members or entities of the Church in general from charitable and tax deductible donations. As Director of the Family Defense League, I have a fiduciary duty to manage certain activities of the Church. I, Glen A. Stoll, neither manage nor control any bank accounts, whatsoever. If any funds or other assets of the Church, such as the Subject Property, were to be used for my personal, financial gain, or to be used to pay any of my personal debts, such as any personal income tax obligation that may arise, such a misuse would be an Unlawful Conversion, Misappropriation of Funds, Embezzlement, Money Laundering, or a combination thereof, and would constitute Fraud. The above named Defendant / Obligated Parties to my Claim for Damages, Cerling, Tran, and Hubbert, are thereby committing and conspiring to commit fraud upon the Church and upon the United States of America.

**29. In rebuttal to the Complaint's page 9, item 48:** The Director of the Family Defense League does not even have a bank account, and I am not aware of the existence of any such a.k.a. as "Family Defense Network" or "Family Defense Fund."

**30. In rebuttal to the Complaint's page 9, item 49:** Their statement here seems to contradict their previous position. If the Family Defense League "is an entity inseparate from Glen A. Stoll" as they allege, and if it "has no interest in the Subject Property" as they also allege, then Glen A. Stoll would likewise have "no interest in the Subject Property." By their own statement here, they are alleging that "Glen A. Stoll... has no interest in the Subject Property." Therefore, their foreclosure request is moot, and the "Subject Property" shall remain in the ownership of the Stoll Family Trust, where it is now.

The undersigned Affiant makes the following Categorical Statement of Fact by this Affidavit:

**31. In rebuttal to the Complaint, beginning on its page 9, item 50:** This item of their Complaint is wholly false and unsupported by fact or law, as evidenced by my verifiable rebuttal. Neither "The Stoll Family Trust and/or (sic) the Family Defense League are sham entities," as falsely alleged.

**32. In rebuttal to the Complaint's page 10, item 51:** This item of their Complaint is wholly false and unsupported by fact or law, as evidenced by my verifiable rebuttal. See all attached Exhibits A-F as well.

**33. In rebuttal to the Complaint's page 10, item 52:** Same as paragraph 32 above.

**34. In rebuttal to the Complaint's page 10, item 53:** Same as paragraph 32 above.

**35. In rebuttal to the Complaint's page 10, item 54:** Same as paragraph 32 above.

**36. In rebuttal to the Complaint's page 10, item 56:** Same as paragraph 32 above.

**38. In rebuttal to the Complaint's page 10, item 58:** The form and substance of their entire Complaint is unsupported by fact, agreement, or law. Therefore, it should be voluntarily withdrawn or summarily dismissed, and the amount of reimbursement as itemized in the Ledger of Obligation (item 45 below) should be paid. If it is not, I will continue my Claim for Damages under the Common Law jurisdiction of my already commenced Commercial Dispute Resolution Process, and file a formal Criminal Complaint.

**39. In rebuttal to the Complaint's page 11, item 59:** Same as paragraph 38 above.

**40. In rebuttal to the Complaint's page 11, item 60:** Same as paragraph 38 above.

**CONCLUSION**

41. The primary Damaged Party herein, Director of the Family Defense League (the Church), has not even been served with the above mentioned and rebutted Summons and Complaint. Said Damaged Party is an integrated auxiliary of the Church, and knows of no other option but to collect and spend the charitable, tax deductible donations it receives in order to cover the expenses it incurs in protecting its property from the groundless action that has been taken by the above named Defendants / Obligated Parties to my Claim for Damages, Cerling, Tran, and Hubbert.

The undersigned Affiant makes the following Categorical Statement of Fact by this Affidavit:

*(Number each point)*

42. The amount of \$500 for CPA Accounting Services, \$650 for legal consultation, and \$200 for legal process services has so far been spent for having to respond to this matter, totaling \$1,350.

43. At this time, the Church is willing to settle for \$1,350 as reimbursement for the expenses it has incurred due to this wrongful action, provided their Complaint is withdrawn or dismissed, and all their claims of Lien stricken and released, prior to the Church filing a Criminal Complaint for Conspiracy to Deprive Rights Under Color of Law, Slander of Title, or other possible causes of action.

44. It has been requested that the Church spend \$50,000 just to begin negotiations with the government in order to stop their baseless attack upon the Church. If this action continues, the Church will seek actual, criminal, and any other damages it may be entitled to from the above named Defendants / Obligated Parties to my Claim for Damages, Cerling, Tran, and Hubbert, and from the government. However, if their Complaint is withdrawn or dismissed now, and all their claims of Lien stricken and released, the Church will agree to hold them harmless for any further Complaint for Damages in this matter.





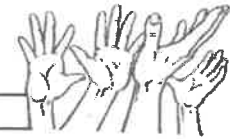

Greetings:

**Please accept this as our Notice of Intent to properly address this matter.** Although I am not an attorney-at-law, nor have I ever claimed to be, I do occasionally provide personal aid and assistance of Counsel to the handicapped and others in need. At this time, I am the one in need.

Since first hearing about this matter on or about October 16, 2022, I have spent the majority of my time attempting to locate competent legal counsel to address the court on behalf of each named defendant. Unfortunately, after reaching out to at least two dozen attorneys, I still have not found anyone willing or able to represent any of the named Defendants. Therefore, I will attempt to do so here. **Please advise.**

## **Named Defendant Glen Stoll**

I (Glen Stoll) am a 72 year old Minister of the Gospel, and have been doing mostly domestic Church missionary and other charitable work for the poor and needy all of my adult life as a dependent of the Church, without ever receiving any monetary compensation or personal gain. Ever since 1993, my residence for all legal, religious, and political purposes has been the Church at 8777 Basl Hill Road, Stayton, Oregon. In or about 2013, our Edmonds Church office and my primary mailing address changed from 9115 - 236th Southwest, Edmonds, Washington 98026 to 16910 - 59th Avenue Northeast, Arlington, Washington 98223. I have neither had nor used any other address, whatsoever, since 1988.

## **Named Defendant Stoll Family Trust**

The Stoll Family Trust (Family Trust) is a family living trust that my parents had created by a now retired estate planning attorney in or before 1992. According to its terms, Janet Spangler is the trustee/executor, Lee Stoll is Janet's successor, and I am Lee's successor as trustee/executor. The named beneficiaries of the Family Trust are Janet Spangler, Lee Stoll, and Glen Stoll or "Director of the Family Defense League" if I were to disclaim the share allocated for me in the Family Trust, which I did disclaim in favor of a perpetual and irrevocable assignment to non-profit Gospel missionary work.

## **Named Defendant Director of the Family Defense League**

Director of the Family Defense League (FDL) is "A Washington acknowledged Corporation Sole of the Church" that I have been overseeing since 2001, and as an unincorporated Church ministry since 1988. Steven Kish is its registered agent at 16910 - 59th Avenue Northeast, Arlington, Washington 98223.

Founded in 1988, the Family Defense League is the parent organization of Administrative Church Counsel. The Director of the Family Defense League maintains its nontaxable status as a charitable, educational, religious corporation sole of the Church, consistent with 508(c)(1)(A) of the Internal Revenue Code with respect to 501(c)(3), and has its charter on file with the Secretary of State in Washington.

It was on or about October 16, 2022 that Janet Spangler informed me she had been served with a Summons and Complaint for a foreclosure action in your court. I then saw that it was based on Substitute for Returns (SFR) alleged to have been prepared by the IRS for the years 2001 through 2008. I was never notified or made aware of any such alleged obligation, nor do I have any such obligation. Those SFRs are based on nothing. I cannot even imagine what they might be thinking they are based on.

I now live in the house at 7311 Grove Street, Marysville, Washington (Church Parsonage) that was owned by my parents, Richard and Mary Stoll. I have never received mail or deliveries there of any kind, nor have I ever used or declared that address as my legal residence to anyone, for any reason, at any time. I am allowed and required to live there as a parsonage because of my administrative services to the Church, as long as I am providing said service for the Church.

Before they died, my parents deeded the Church Parsonage to the Family Trust, of which Janet Spangler served as trustee/executor. The designated beneficiary of the Church Parsonage is FDL, its registered address being 16910 59th Ave NE, Suite 210, Arlington, Washington 98223, and its registered agent being Steven Kish at that same Arlington address. Surprisingly to us, the Snohomish County Auditor's records apparently do not show any transfer of deed from the Family Trust to FDL, but do show FDL as being payer of the real estate taxes.

Except for the summons served on Janet Spangler on or about October 16, neither Janet Spangler, nor Steven Kish, nor I have ever been served or notified of any foreclosure or pre-foreclosure documents, or anything else pertaining to the allegations leading to this foreclosure action at any time.

On October 20, 2022 I received a phone call from Assistant US Attorney Jeannette Tran asking if I will help her serve me with legal papers. I stated that I will be contacting an attorney and follow that advice. I agreed to call her back before 5:30 PM on that same day. When I called her back at or about 4:30 PM, I got her voice mail and left a message that I was advised to go and get the documents if she would tell me where I could pick them up. However, I have not heard again from AUSA Tran or anyone else regarding legal process services.

The Church has recently hired a CPA/IRS Enrolled Agent to prepare original tax returns for me to replace the SFRs for those years 2001-2008. I did not file previously because I had no income due to my volunteer ministry work as a dependent of the Church. I have had no training in tax law, nor have I ever spent time or ever claimed to have spent time studying the tax laws. Therefore, I relied on the advice of the Church's CPA/IRS Enrolled Agent at the time, who informed me that since I had no taxable income, I had no obligation to file a federal tax return.

## **Brief Autobiography of Glen Stoll - regarding work experience**

Compiled on November 22, 2022

For nearly all my adult life I have been doing charitable church mission work without any direct payment for my personal gain. All compensation for my services, if any at all, goes directly into the ministry. In turn, the ministry provides me with a place to live, for other basic necessities of life, and for the basic support of my family. I own nothing and have no personal income. I was raised in the greater Seattle area during the 1950s and 60s as a *Christian Scientist*, was a member of the *Boy Scouts of America* (including Cub and Explorer Scouts), the *Future Farmers of America*, and was a founding President of the *Edmonds Junior Sportsmen* club.

Following my personal conversion to Jesus Christ as Lord, Saviour, and King, and one month after my baptism in 1970, I was appointed as Youth Leader and Sabbath School teacher at the *Seventh-day Adventist Church* in Davenport, Iowa. I was later ordained there as a Church Deacon in 1971, at which time I also began my ministry service as a Literature Evangelist.

After practicing Chiropractic as a student intern at the *Palmer College Clinic* in Davenport, Iowa in 1974 and 75, I began work at *Yuchi Pines Medical Missionary Institute* in Seale, Alabama as the exclusive Resident Physician of its in-patient health care facility. From there, I returned to the Seattle area in 1980 as the Community Services Director of the *Shoreline SDA Church*, where I was also ordained as an Elder/Assistant Pastor.

In 1988, I founded the *Family Defense League* in order to provide a religious liberty, human rights, and Church administration service. That service was supported by several prominent attorneys and other professionals in the Greater Seattle area, some for whom I worked as a legal aid, and received Law Clerk tutoring to qualify for bar membership. See attached two page paper called, "Professional Guidance (2021-10-25)." Although I chose not to join any Bar Association for religious reasons, we established *Remedies at Law* in 1993 as our Church ministry law firm.

Also in 1993, the *Family Defense League* and *Remedies at Law* began its association with the *Embassy of Heaven Church*, and I formally expatriated (resigned) from the United States Corporation in favor of exclusive Church citizenship and residency. The *Embassy of Heaven Church* has served as our Church Registry and records verification service ever since.

By 1999, I had traveled seven times across the U.S./Mexico boarder on Medical Missionary journeys. During each of those crossings, I formally identified myself by using my Church issued passport as a Citizen of the Kingdom of Heaven and Resident of the Church, with the full knowledge and official approval of the U.S. Port Director at Columbus, New Mexico, and of numerous Inspectors from both countries at that and other border crossings as well. I also had direct face-to-face interaction on official business with the Arizona Director of Motor Vehicles by working with him, at his desk in his office, at the state capitol in Phoenix, and with the Sheriff of Luna County, New Mexico; all exclusively as a Church Resident/Citizen.

Over the years, I have worked very closely with many other church denominational leaders, members, and congregations, too numerous to mention. In addition to serving in the Seattle /

Tacoma / Everett areas as an Elder/Pastor at the *Shoreline SDA Church*, and at the *Arlington SDA Church*, I also founded two independent Church Fellowships (companies) where I served as Elder/Pastor/Teacher, namely: (1) *Renton Christian Center* in Renton, Washington in 1990 (no longer there); and (2) *Namesake Fellowship* in Everett, Washington from 2014 to present.

In 2001, I established and currently run a clean and sober safe house in Marysville, Washington called the *Hospitality House*, affiliated with the *Family Defense League*. We receive referrals from such agencies as the *Washington State Department of Corrections*, *Snohomish County Housing and Emergency Needs (HEN)*, *YM/WCA*, *Salvation Army*, *Goodwill Industries*, and *Volunteers of America*, and have since been developing a life skills training, work ethics and placement program, affiliated with *Ecclesiastical Enterprises*. In 2012, I began the *Adventure Club* mentoring program for underprivileged, at-risk, and special needs youth, in cooperation with the *South Everett Community Church* (Southern Baptist) in Everett, Washington.

Our ministries and I have been under intense investigation by the U.S. government ever since 1993. That was the year the Family Defense League opened our Church law office called Remedies at Law. Undercover government agents have been attending our classes for the purpose of determining the validity of our program. Some of them have even provided us with Professions of Faith and other certifications in order to participate in our full Church services, and are now claiming those certifications to be false, thereby, admitting to fraud against the Church.

Our garbage has been regularly intercepted and sorted through, many of us have been followed on the highway during some of our travels, and have been subjected to what they called "drive by surveillance" and "walk through surveillance." They have not yet admitted to any electronic surveillance, other than secret video recordings of our church parsonage in Marysville.

In 1998, Deputy Sheriff Duane Fletchall of Marion County, Oregon organized a raid on the Embassy of Heaven Church with which we are affiliated. Deputy Fletchall extracted his own membership records, which were property of the church, and they were never returned. According to the IRS agent who accompanied Sergeant Fletchell, he had been investigating the wrong place for many years prior to the raid. After discovering this and other errors, the Marion County District Attorney abruptly ordered Fletchell to stop what he was doing, shouting his disapproval, "We have just raided a church!"

In 2003, an undercover IRS criminal investigator testified in Seattle federal court about our ministry. As documented in a two-page summary of his testimony called, IRS Report on Remedies at Law, he said, "[T]hese programs that Mr. Stoll and his associates are promoting may seem to have a lot of earmarks of tax evasion, but to my knowledge, these are not illegal... Vehicles for establishing trusts that do those things have a very legitimate purpose, and are certainly legitimate within the eyes of the IRS."

In 2005, I was notified that a civil injunction had been entered against me in Seattle federal court, without giving me any prior notice or opportunity to respond. It claimed that I was in criminal violation of the tax laws, based on a stack of documents that were alleged to have come from me. Those documents were not from me. They stated things I largely oppose and teach against.

The Seattle injunction ordered me to divulge confidential Church membership records, which I never did, to stop violating federal tax laws, and to provide them with a Certificate of Compliance. Instead, I issued a Certificate of Integrity, stating that I had never violated those laws, and that no evidence could possibly exist to the contrary.

On May 4, 2006, a fellow church member and I attended a small Religious Liberty rally that was hosted by our church in Washington DC. We had dinner with Senator John McCain and Representative Roscoe Bartlett who agreed to look into the Seattle federal court matter. The following day, we met with the USDOJ Tax Division Lead Attorney on the case, Martin Shoemaker, in his office for over two hours.


As documented in a memorandum dated May 18, 2006, and filed with the court thereafter, Shoemaker said, "As I stated to Stoll and his associate when they visited me in my office on May 5, 2006, our department is not concerned with what they may or may not have done in the past. Their assurance to me that they will not engage in any such activities in the future is enough to satisfy this concern."

I often hold free one and a half hour seminars for Church organizations, by telephone and in-person, called, "Organizing Your Ministry" on the subject of Natural Church Jurisdiction. Sometimes the seminar is extended into a series of classes. A 25 page packet of documents for this seminar is available upon request, which also serves as a syllabus for a three month certification course in Church Administration offered by the Arlington Law School.

Occasionally, I also serve as a health care advocate, legal advocate, assistant, or personal aid by providing whatever assistance, advice, or representation may be need for handicapped people and others in the areas of Religious Liberty, Human Rights, Personal Privacy and Protection, or other Church Administration Services.

I understand the penalties of perjury, and am willing to be held to those standards regarding everything I have stated in this Brief Autobiography and its references.

## **Dependent of the Church and Steward of God**

The Church itself has no “name” to speak of. However, many local communities of believers do. One of the names that is used by the Church to identify the local congregational fellowship I am directly accountable to is Namesake Fellowship; others are Hospitality House, South Everett Community Church, and Shoreline Seventh-day Adventist Church. There is also an innumerable variety of missions or ministries around the globe that are integrated auxiliaries, conventions, and associations of churches that I am also responsible for and accountable to; and they have a responsibility and accountability to me as well; such as Family Defense League, Remedies at Law, Administrative Church Counsel, Embassy of Heaven, Heavenly Leaves, Heaven Ministries, Creation Science Evangelism, Abundant Life Ministries, and many, many more.

I do not receive any salary or wages. When I have a need for a product or service, I defer to our Independent Missionary Agreement, consult with others who are involved with the ministry, ask the people in my local Bible study group, our fellowship congregation, or other extended Church members and family for help. My wife does occasional grocery shopping when funds are available and as the need arises, but we get a large amount of food donated to us. Funds are often donated to us specifically for food purchases, and we are taken out to dinner quite often. We have neglected to apply for property tax exemption on our parsonages and other Church real estate. I intend to approach the other Church officials about applying for it. In the meantime, property taxes are being paid on the parsonage where I am living by the Family Defense League, and the taxes on the building where we commonly fellowship are paid by Namesake Fellowship.

I do not have a personal bank account and I do not own a car. Other people drive me where I need to go, an automobile is provided by the Church for us to use, I use public transportation, or I walk. The funds for maintenance and repairs of Church vehicles sometimes come from the Membership Fees for its clean and sober house program called, the Hospitality House. I am the Program Director, but I receive no income, wages, salary, or stipend. The Church also provides phones for meeting our communication needs, as well as the transportation needed to get me to the Hospitality House and elsewhere, to hold weekly house meetings, Bible studies, individual counseling, and to oversee repairs and maintenance that is needed from time to time.

I do not have lawful ownership of any of the items that are in my possession. The Church parsonage I am allowed to live in comes fully furnished. Items that are needed from time-to-time are purchased by the Church, its members, or one of its various ministries. Needed items, repairs and maintenance are often gifted to the ministry; items such as guitars for worship and praise to our Heavenly Father and our Lord Jesus Christ, electronic equipment like computers, large display screens, microphones and speakers. Most of the furnishings in the house and elsewhere are either donated to the Church or purchased by the Church at a bargain price.

The Church arranges, takes responsibility, and pays for all utilities and other services that I need and make use of while in full-time service to it and its various missions. These would primarily consist of the utilities at the parsonage, the fellowship hall, and the clean and sober house.

My wife and I were lawfully married at a Ceremonial Covenant Wedding, after first obtaining a paperless license directly from her dad as her covering, by him giving permission for us to wed. We were not legally married, and have no Marriage Certificate on file with any secular state. Our marriage was entered into as a sacred ordinance of the Church. The Church does not keep any

kind of secular records such as state ID numbers (e.g. SSN or DL) and DOB. Nor do I have any knowledge, interest, or access to such information. My wife has her own lawyer, and I have been instructed to direct anyone requesting any information about her to contact her lawyer directly.

I do not use, and do not have a Social Security Number. It is my understanding that my parents had obtained one for me at one point in time. I have searched my personal records to the best of my ability and have not been able to find any evidence of a former Social Security Number or Date of Birth for me or my wife. I simply never use such things of the world and have no interest in them. However, I was able to locate a conformed copy of an Affidavit of my parents, that they had prepared many years ago.

It is my understanding that a "Date of Birth" is the date of the creation of an instrument, Certificate of Live Birth, that establishes someone to be a "human resource" and resident of the state. I am not a "state resident" but baptized and born again as "fellowcitizens with the saints, and of the household of God," Ephesians 2:19. I recall the day of my baptism; it was 4/12/1970, and I would have been about 19 years old at the time. For some strange reason, however, my official Baptismal Date is 4/14/1970. Unless and until the Church Records are ever corrected, I often use the latter Baptismal Date in place of a state issued DOB when one is requested of me. But whenever I do that, I always make sure it is clear that this is a Baptismal Date and not a DOB. I do not have a state issued DOB any more than I have a state issued SSN. There was a day upon which I was born of the flesh, of course, but I do not use, or have, or recall any such event. Here is how my parents, who have been dead for a decade now, put it in their Affidavit:

The purpose of this affidavit is to provide information of which we have personal knowledge, from our own recollection, regarding the legal and political identity of our son, Glen Stoll. Although we are his natural parents, we actually recall very few circumstances surrounding the event of his birth. Without any supporting documents or hearsay information, we cannot state the actual date of his birth from our memory of the event itself. We were too occupied with the issues of the pregnancy to take specific note of what day it was at the time. We do recall, however, riding in our 1949 Plymouth Suburban on the evening before his birth. We had purchased the car from Hopper Chevrolet in Edmonds, Washington near where we had been living during the time Glen was born. We got the car new from the dealer, but they gave us a much lower price because it had been driven for 700 miles as a demonstrator and they wanted to clear it out to make room for the new 1950 models. We traded it in for a pickup truck to start our plumbing business in about 1951.

Glen was raised according to our mutual belief system. We are not joiners, and never have been. Although we have never been official members of any church congregation or denomination, we did attend church meetings here and there from time to time. The basis of our faith was from doing a considerable amount of reading, by learning from the experiences of life, and from receiving divine inspiration directly without much outside intervention or interpretation. As a result of our beliefs, Glen was never allowed to have vaccinations or inoculations of any kind. We first sent Glen to attend school in the basement of a church in the Edmonds area. Our beliefs are deeply held convictions, not simply preferences. We believe in living according to the will and purpose of God, the Supreme Creator and Devine Healer, as He reveals Himself to us.

Consistent with the above mentioned belief system, we have never given Glen over to the state to become one of its human resources. This means that, to the best of our knowledge, he has never had a certificate of birth that would legally make him resident political property of any secular state, nor have we ever knowingly allowed him to have any other connections that would cause him to owe a duty to any local or federal secular authority. We have instilled upon him, as we believe, that he is a perfect child of God, within the consciousness of Christ, and wholly dependant on Him. He was raised to be independent from all of the anti-christ systems of the world.

When I was in or aware of the following situation:

In 2003, Glen Stoll began providing our ministry, Creation Science Evangelism, with Church administrative services. We had about 40 staff members who were independent missionaries, as our contract prohibited us from having employees, or even employee-like relationships. We had been locked-out of many of our buildings by the county, and I was facing two criminal charges in state court. In 2005, when I was arrested on federal charges of financial structuring and employee tax evasion, all alleged to have taken place prior to 2003, the IRS Criminal Investigators confiscated papers from me that were deemed to be anti-government tax protester propaganda. The government claimed that those papers were representative of what we were doing at our ministry and what Mr. Stoll was advising us and assisting us to do. They were not.


Glen Stoll or an associate of his ministry provided:

Mr. Stoll represented me (pro hac vice) on the two state charges, was responsible for getting me off both of those criminal charges, and had all of our buildings re-opened in short order. Mr. Stoll had personally reviewed the propaganda papers that were mentioned in the paragraph above, and strongly advised us against following them. He advised and assisted us in following the law as the IRS Agents and other government officials believe it to be, without qualification or argument, and as carefully and completely as possible, which we did. Mr. Stoll was also responsible for securing some real estate tax exemptions for us that we did not have on any of our ministry properties prior to his involvement.

This was the result:

From the time Mr. Stoll began providing our ministry with his Administrative Church Counsel, assistance, and advice in 2003, we have followed it almost completely, and have never had any trouble as a result. The only exception and trouble we have had as a result, and it has been considerable, was from following the counsel of those who preceded Mr. Stoll in the administration of our ministry, of those who produced the propaganda papers mentioned above, and of those I hired to advise and represent me in federal court. I did not have Mr. Stoll testify, assist, or represent me in that federal case, and I was convicted and sentenced to 10 years in prison as a result. The first thing I said to him upon calling him after the guilty verdict was read was, "I sure wish I would have followed your advice."





**IMPORTANT NOTICE:**

THIS CORPORATION IS REGISTERED WITH THE BODY OF CHRIST, THE ONLY TRUE CHURCH (Ephesians 4:4-16). HAVING ITS AUTHORITY AND POWER ORDAINED OF GOD (Romans 13), THIS CORPORATION HAS BEEN CHARTERED BY THE KINGDOM OF HEAVEN UNDER ITS LAWS OF SERVICE TO OTHERS (John 13:14). THE PURPOSE OF THIS WRITTEN INSTRUMENT IS FOR NOTIFICATION TO THE SECULAR WORLD, NOT REGISTRATION WITH IT (John 17:16 & 18). On that same day Glen Stoll canonically took possession of said office as the first duly appointed and qualified overseer for this corporation. Authority is hereby granted to any secretary of state, county recorder, or similar recording agency, to file this Charter and perform the service of making it available to all people as a matter of record for public inspection. Any filing of this Charter, other than its original filing for registration with the church, is for recording and inspection purposes only and may not be construed, interpreted, or utilized as registration with any other governmental body. The filing of this Charter, containing the following Articles of Incorporation, has been approved for acceptance under the above conditions by **Washington: 24.12 RCW, and RCW 36.18.010, 65.04.080 and 110; United States of America and Each of its Member States: US Constitution, Article 4, Section 1; and Amendments 1 and 10; Other Nations of the World: English Common Law, The Law of Nature and of Nature's God, and the International Law of Nations.**

#### **ARTICLE I — Name and Identification**

The name of this corporation sole is Director of the Family Defense League. The names of its integrated auxiliaries, conventions, and associations are maintained privately by the ministry including, but not limited to: Remedies at Law, its d/b/a fund raising projects, trade names, or pure trust organizations. Neither this corporation nor any of its affiliates shall hire employees or engage in other federal, state, or local taxable or secular licensing activities. Therefore, consistent with 26 USC 508(c)(1)(A), they are "mandatory exceptions" from federal, state or local taxation or secular license by their very nature; and as clarified by IRS Publication 1828 at page 5, "No special number or other identification is assigned by the IRS as evidence of an organization's exempt status." Nevertheless, a nontaxable church Trade Identification Number (T.I.N.) may be assigned and provided by the Registrar or Registered Agent for this corporation.

#### **ARTICLE II — Registered Agent, Mailing Address, and Location**

The Registered Agent and mailing address for the Registered Office of this corporation shall be that of its Associate Counsel, Michael Stevens of Remedies at Law [9115-236th Street SW, Suite B, Edmonds, Washington 98026; phone 425.673.7762]. Registration shall be under the jurisdictional authority of the Kingdom of Heaven alone, and shall be provided through the Embassy of Heaven [8777 Basl Hill Road, Stayton, Oregon 97383; phone 503.769.5034], or other similar agency capable of issuing and maintaining licenses and records for the church in the Kingdom of Heaven under our King Jesus Christ, the Son of God and Saviour of the world. The place of location of this corporation shall be within the territory of the Kingdom of Heaven, which reigns supreme throughout the fullness of the Earth and the entire Universe, including, but not limited to the above addresses.

#### **ARTICLE III — Statement of Purpose with Vow of Poverty**

The mission statement for this corporation that provides the foundation for management of its ministry is made by a Declaration of Status, which is found on page 6 of this charter and substantially restated here: 1) The Director of the Family Defense League, sole overseer for the Family Defense League, having taken a vow of poverty as an indigent, dependent of the Church at large, and being constrained by the love of Christ to the duties and responsibilities that rest upon the Director (2 Corinthians 5:14-20), will make no plans for self but be continually open to the guidance of the Holy Spirit day by day. 2) The purpose of this corporation is for the promotion of Christian ethics, to establish law under grace and justice with mercy, and to "proclaim liberty throughout all the land unto all the inhabitants thereof" Leviticus 25:10; for the justification, sanctification, and glorification of an indefinite number of natural people consistent with the cause of Christ our King. 3) Worthwhile projects for the common good of the assemblage of the ministry and its potential membership, along with other acts and programs beneficial to the assembly at large, are to be administered. 4) The operation of this corporation is to be in keeping with "the Golden Rule," the Ten Commandments of our Eternal Creator and the Testimonies of Jesus Christ that all might come out and completely separate from the "Babylonian" systems of the world to experience the peace and joy of the Kingdom of Heaven. 5) The mission plan unique to this ministry shall be achieved by researching, developing, and implementing the principles set forth in its Declaration of Status.

#### **ARTICLE IV — Property, Other Assets, and Duration**


The property of this corporation is managed exclusively not for profit and is irrevocably dedicated to religious, educational, medical, scientific, and family missionary purposes. No taxable income shall ever be generated, received, or derived from any source for the use, purpose, or benefit of this corporation; and no part of any funds or other assets of this corporation shall ever inure to the benefit of any overseer, officer or member thereof or to the benefit of any private person other than for the purposes stated in these Articles of Incorporation. All title to or equitable interest in real or other property held by this corporation shall be held in trust for the use, purpose, benefit, and behoof of the Family Defense League. Any and all assets being held or received in the individual name of any Director shall be in the official overseer capacity and deemed as if in the name of the corporation alone. Although it is intended for the duration of this corporation to be perpetual, with successor overseers as defined in Article VI, should it ever become necessary for a dissolution or winding up of this corporation to occur, its assets remaining after payment or provision for payment of all debts and liabilities shall be distributed to the Director and General Counsel of Remedies at Law, or its successor, a Corporation Sole that is on file with the Secretary of State in Oklahoma, and under the same nature of existence as this one.

#### **ARTICLE V — Powers, Sovereign Immunity, and Authority**

This corporation, for the purpose of its ministerial trust, shall have the power to contract in the same manner and to the same extent as a natural person. It may sue and be sued at its sole discretion, according to the doctrine of sovereign immunity. It may likewise function in all Courts of Justice and places of Lawful jurisdiction, in all matters and proceedings whatever. It shall have authority to give or receive promissory notes and to secure the payment of the same by a grant, pledge or other lien upon property, real and personal; to buy, sell, lease, grant, pledge and in every way deal in real and movable property in the same manner as a natural person may. It may employ assistance of Counsel, whether union or nonunion; to the extent that no such assistance of Counsel shall ever be utilized in any capacity greater than subordinate co-counsel; to protect the rights, duties and responsibilities of this corporation and its ministry; and to address all courts or other bodies in any and all matters whatsoever, whether National or International.

#### **ARTICLE VI — Title of Overseer, Membership, and Succession to Office**

"Director" is the official title for the overseer of the Family Defense League, which is this corporation's sole office and its only member. The manner of filling any vacancy that may occur in the incumbency of the office of the Director of the Family Defense League, is specified in the rules, regulations, and discipline of the ministry's Constitution, By-laws, Canons and Ordinances that are maintained privately by the ministry. Every succession shall be confirmed in gathering from an appointment by the Holy Spirit, effected by means of spiritual birthright as set forth in the most currently available performance contract; formally approved in solemn convocation of clerical staff and general membership of the unincorporated missionary assembly.
