COMES NOW the State of Montana, by and through Assistant Attorney General Thorin A. Geist and Madison County Attorney David Buchler, and hereby notifies the District Court that the Defendants have failed to comply with its Order on State's First Motion to Compel (Ct. Doc. #61) as follows:

1. On March 16, 2023 the Defendants were ordered to **<u>immediately</u>** file

with the District Court a Notice of Affirmative Defense Witnesses that

fully complied with § 46-15-323(2) and (4), MCA. Order at p. 1-2. To date, the Defendants have failed to comply.

2. On March 16, 2023, the Defendants were ordered to <u>immediately</u> provide the State with contact information for all witnesses that they intend to call at trial, including those who would be be called in support of their affirmative defenses. *Id.* To date, the Defendants have failed to provide contact information for five witnesses.<sup>1</sup>

The District Court warned the Defendants that "failure to comply will result in sanctions being imposed pursuant to § 46-15-329(3)-(4), MCA." *Id.* Having failed to comply, sanctions should now be imposed.
