Greetings:

After contacting well over 600 attorneys about this case, I have not yet found anyone willing or able to file a Notice of Appearance as you have ordered. A few attorneys out of the area said they may be able to appear pro hac vice, but that it would require a local attorney to sponsor them, which they don't believe they will be able to find.

Our first efforts to obtain counsel began the day after Janet Spangler was served for the Stoll Family Trust. We contacted dozens of attorneys at large and small firms. I have continued contact dozens more, some as recent as this morning. Many of the attorneys interviewed me themselves, while some used paralegals for initial screening. I always asked for referrals to other attorneys, and usually got them. A few attorneys actually agreed to take the case at first, only to change their minds a day or two later.

Among the reasons given for not taking the case were that it is not within their scope of practice, that they are retiring, that their case load is too heavy, or that they discovered a conflict after researching my name. That last reason seemed very curious to me.

It appears the plaintiff in this case has circulated press releases that contain provably false and defamatory statements about me. Those press releases are readily found on the Internet and have become the basis for gossip bloggers and various organizations to put me on their "bad boys" lists.

I have contacted the Washington State Bar Association, who told me they provide no services to the public, that they only exist for the benefit of their members, and their authority to exist comes from the Washington State Supreme Court (WSSC). So, I contacted the WSSC who referred me to two pro bono programs; one was for landlord and tenant issues, and the other was Northwest Justice Project (NWJP).

An initial screening by the NWJP determined that I qualify for their program. However, after an interview with their Foreclosure Prevention Unit Paralegal Missy Jordan, she determined that they will not be able to help me. She provided me with the enclosed list of 18 law firms that she recommended. Most of those on her list are ones I have already contacted. I have contacted firms on her list, firms they referred me to, firms others have referred me to, followed by firms the referred firms referred me to, etc.

Furthermore, I have contacted both the Snohomish County Bar Referral Service (425-388-3018) and the King County Bar Referral Service (206-267-7100 and lrs@kcba.org). Neither of those organizations have been able to provide me with the counsel or referrals to the counsel we are seeking.

Therefore, we hired an artificial intelligence (AI) company, Tempest AI, a subsidiary of Renaissance Growth, LLC, for \$300 to do a custom attorney search and \$100 for process service, for which I hereby request reimbursement. They have sent almost 600 emails to their specialized list of attorneys who would be most likely to take this case. Those emails contained the following message: "We need an attorney who can represent my deceased parent's family living trust. Seattle US District Court Judge Zilly is threatening a default if the trust is not represented by an attorney no later than April 14th. Can you help? Please call EVEN if you can not agree to help by April 14th. Call me back at (425) 508-2302"


So far, no positive replies have been forthcoming. An option was provided for them to either call me directly, or to email a reply to the AI company. I have received only one call back directly. That was from a firm that said they do not practice in Seattle US District Court. Please see the attached letter from Philip Nelson of Tempest AI with their technical demographics and results, wherein he said that 86.72% of the emails were received, 15.29% of them were opened, and 0.17% of the recipients responded. So far, all responses have been negative, but there is a possibility that more responses may yet arrive.

I am very disappointed at my lack of success in finding an attorney, in spite of my extreme efforts. It appears to be an impossible task. There may be no attorney in existence who will take this case.




