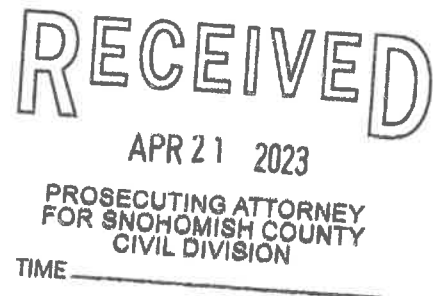

AFFIDAVIT

The undersigned Affiant states as follows:

**Affidavit of Janet Spangler in Support
of Criminal and Civil Complaints**

I am the sister of Glen Stoll and daughter of Richard and Mary Stoll. During or before 1992, our parents had an estate planning attorney (now retired) create an irrevocable family living trust, of which I served as its trustee/executor. They named it the *Stoll Family Trust*, wherein, among other things, they transferred the Subject Property at 7311 Grove Street, Marysville, Washington by *Quit Claim Deed* (see two deeds attached as **Exhibit A**). The designated beneficiary of the Subject Property is *Director of the Family Defense League* (Washington State Unified Business Identifier Number 602 092 549), its registered address being 16910 59th Ave NE, Suite 210, Arlington, Washington 98223.

While settling their estate in 2012, it was my intention and belief that I had transferred the Subject Property from the *Stoll Family Trust* to the *Director of the Family Defense League* according to the instructions I was required to follow. I recently discovered the Snohomish County Auditor's records do not show any such transfer of deed. However they do show the *Family Defense League* as payer of the real estate taxes.

The named beneficiary of the Subject Property in the *Stoll Family Trust* was to be Glen Stoll, unless he chose to disclaim it, which he did, in which case it was to be the *Director of the Family Defense League*. It was my understanding that the Subject Property was to be used for non-profit Gospel missionary work.

On or about October 16, 2022 I was served with a Summons and Complaint for a foreclosure action in the United States District Court at Seattle under Case No. 2:22-CV-01130-TSZ against the Subject Property. The Complaint was based on Substitute for Returns (SFR) alleged to have been prepared by the IRS against Glen Stoll for the years 2001 through 2008, and resulting Notice of Federal Tax Liens being placed on the Subject Property in 2017 (see **Exhibit B**). As the exclusive agent for the property owner, I was not even then provided with evidence or copies of any such obligation or liens. It was only yesterday that Glen provided me with copies of the four liens that he found last week to exist in the Auditor's Office.

Although Glen lives at the Subject Property, I am aware that he does not receive mail or deliveries there. Except for the summons served on me on or about October 16, 2022, I have never been served or notified of any foreclosure or pre-foreclosure documents, or anything else pertaining to allegations leading to a foreclosure action. The Subject Property was not ever to be transferred to a nominee or alter ego of Glen Stoll. The *Stoll Family Trust*, of which I am its exclusive agent, is the current and sole owner of record of the Subject Property, and has been ever since the 2005 *Quit Claim Deed* was granted. Based upon the final instructions I received and followed, the beneficiary of the Subject Property is not to be Glen Stoll, or to be used for his personal gain or to pay his debts.

AFFIDAVIT

The undersigned Affiant states as follows:

As exclusive agent for the *Stoll Family Trust*, owner of record of the subject property, I have never received any *Statutory Notice of Deficiency* or anything like it at any time. No opportunity was ever given for me to contest a *Statutory Notice of Deficiency* as no such notice like it was ever given. No notice of assessments against Glen Stoll for unpaid federal income taxes was ever given to me at any time. No similar notice of any kind was ever provided to me. No demand for payment was ever made, and no such assessments were ever provided to me. Nothing of the sort was ever known by me to have even existed.

Glen Stoll, has never been the owner of the Subject Property at any time. The *Stoll Family Trust* is not and never has been used as a shell to shield Glen's assets from tax collection. The current ownership of the Subject Property is the *Stoll Family Trust* which is required to assure the transfer of ownership and use of the Subject Property to the *Family Defense League*, for the benefit of church ministry. Glen made the decision with respect to the Subject Property to expressly disclaim that portion allocated to him, consistent with paragraph 2 of Article VII (B) of the *Restatement of the Stoll Family Trust Agreement*.

The Stoll Family Trust has no funds and therefore, cannot cover its own expenses incurred in protecting the Subject Property from any action that may be taken against it. Federal tax liens now exist against the Subject Property. The perpetrators (1) have never notified or even attempted to notify the property owner of record that they intended to make such a claim of lien against said property, (2) have not demonstrated any connection of a legal obligation between the property owner of record and the alleged debt or alleged debtor, and (3) did not ever notify the property owner of record that they had made such a claim of lien against the Subject Property.

Just as they were able to easily identify and notify the property owner of record with service of process to commence their current lawsuit in federal court; they had an even greater duty of care to notify all parties, especially the owner of record, that they were making such an ominous claim. The *Stoll Family Trust* is the owner of record of the Subject Property. The *Family Defense League* has a vested interest in the Subject Property, since the *Director of the Family Defense League* is the named beneficiary to become the next owner of the Subject Property.



TITLE 18 SECTION 242 (18 USC 242) - DEPRIVATION OF RIGHTS UNDER COLOR OF LAW;

Whoever, under color of any law, statute, ordinance, regulation, or custom, wilfully subjects any inhabitant of any State, Territory, or District to the deprivation of any rights, privileges, or immunities secured or protected by the Constitution or laws of the United States, or to different punishments, pains, or penalties, on account of such inhabitant being an alien, or reason of his color, or race, than are prescribed for the punishment of citizens, shall be fined not more than \$1,000 or imprisoned not more than one year, or both; and if death results shall be subject to imprisonment for any term of years or for life.

THEREFORE, it is incumbent upon the United States of America to prosecute for fraud (drawing a wage for disservice) and misprision (misuse of public office), and other criminal acts described herein.


