VERIFIED APPLICATION TO REVOKE BAIL AND REQUEST FOR WARRANT

COMES NOW the State of Montana, by and through Assistant Attorney General Thorin A. Geist and Madison County Attorney David Buchler, and hereby apply to the District Court for a warrant authorizing the Defendants arrest if and when they enter Madison County, Montana.

The facts which form the basis for the State's request are as follows: In pertinent part, § 46-9-505(2), MCA, provides:

- (2) On verified application by the prosecutor setting forth facts or circumstances constituting a breach or threatened breach of any of the conditions of the bail or a threat or an attempt to influence the pending proceeding, the court may issue a warrant for the arrest of the defendant.
- (4) Upon the arrest, the defendant must be brought before the court without unnecessary delay and the court shall conduct a hearing and determine bail in accordance with 46-9-311.

§ 46-9-505(2), (4), MCA (Emphasis supplied).

On January 23, 2023, the Defendants appeared before the District Court and plead not guilty to the charges set forth in the *Information* (Ct. Doc. #3¹). *Minutes* at p.1. (Ct. Doc. #28). Each of the Defendants were allowed to remain in the community on \$50,000 bail subject to conditions of release that included that they "stay away from the victim's property." *Bail Order* at p.1. (Ct. Doc. #29); See also *No Contact Order* attached hereto as **Exhibit 1**.

On or about May 6, 2023, the Defendants Jesse Boyd posted on social media that they were restarting their walk "from the very point it was sabotaged." *Facebook* post attached hereto as **Exhibit 2**. Similar posts have been made by the Defendants on other websites, encouraging others to rally at

the same location<sup>2</sup>. Website attached hereto as **Exhibit 3**. Local media has also reported on the upcoming event. News Article attached hereto as **Exhibit 4**.

The Defendants have threatened to violate their conditions of bond by returning to the victim's property. The Defendants are also attempting to influence this proceeding by encouraging others to rally at the victim's property. The State of Montana supports the Defendants right to continue their walk, but they cannot violate the District Court's orders or intimidate witnesses along the way. As such, the State of Montana requests that the Defendant's bond be revoked and that the District Court issue a warrant authorizing the Defendants arrest if and when they enter into Madison County, Montana.



You are further prohibited from, and required to stay 1500 feet from them, their residence, and place of work, or other known locations.

Violation of this no contact order is a **criminal offense** under the law MCA **45-5-209(8)(a)** (of which an offender convicted of a violation of a no contact order shall be fined an amount not to exceed \$500.00 or be imprisoned in the county jail for a term not to exceed 6 months, or both) and may result in your arrest.

You may be arrested even if the person(s) protected by this no contact order invite or allow you to violate the prohibitions. This order remains in effect until further ordered from this Court.
